Summary: The Central Hollywood Neighborhood Council OPPOSES the motion by CMs Koretz and Lee to resolve the City in opposition to AB 1401, which seeks to eliminate minimum parking requirements for housing built within 1/2 mile of public transit. Parking minima increase housing costs, exacerbating the housing and homelessness crises that the City Council has sought to remedy. Parking minima for units located near transit additionally encourages automobile use, exacerbating the climate crisis that the City Council has also sought to remedy. While the motion argues that parking minima incentivize affordable housing production because adding low-income units enables developers to avoid them, affordable housing production increased six-fold when San Diego eliminated its parking requirements. This empirical evidence undermines the principal rationale for opposing AB 1401. As such, CHNC urges the Council to reject this motion rather than erode its own objectives via an affirmative vote.

The Central Hollywood Neighborhood Council (CHNC) **OPPOSES** the 21 April motion by CMs Koretz and Lee to resolve the City in opposition to AB 1401, which seeks to eliminate certain minimum parking requirements for housing built within ½ mile of public transit.

Forcing developers to provide a minimum number of vehicular parking spaces per unit increases housing costs by reducing supply, precluding economies of scale, or requiring otherwise unnecessary excavation. Parking minima therefore exacerbate the housing and homelessness crises and erode the City Council's express ambitions in remedying those emergencies.¹

Forcing developers to provide a minimum number of vehicular parking spaces per unit **when those units are located near transit** additionally encourages automobile use when alternatives exist. Parking minima therefore add to—or do not reduce—LA's carbon footprint, exacerbate the climate crisis, and erode the Clty Council's express ambitions in also remedying that emergency.²

The motion argues that parking requirements incentivize affordable housing production because adding units reserved for low-income tenants enables developers to avoid them. Yet, **affordable housing production increased six-fold when San Diego eliminated its parking minima**—from 272 units in 2019 to 1,564 units in 2020.³ As such, eliminating parking requirements does not harm affordable housing production, obviating the principal rationale for opposing AB 1401.

CHNC has demonstrated its commitment to alleviating LA's homelessness, housing, and environmental crises many times. We know the Council shares our goals. We therefore urge you to reject this motion rather than undermine our joint objectives via an affirmative vote.
