

The Board of the Studio City Neighborhood Council (SCNC) supports Council File 21-0002-S196: Title Cash Bail / Reinstatement / Temporary Zero Emergency Bail Schedule / COVID-19. California voters rejected Proposition 25, which proposed ending the cash bail system in the State. We are in support of this resolution, which seeks City Council and Mayoral approval whereby the City of Los Angeles includes in its 2021-2022 State Legislative Program SUPPORT for legislation that would reinstate cash bail.
