Re: CF # 21-0329-S5: OPPOSE motion and support LAMC Sec. 41.18

Dear Mayor Bass, President Krekorian, President-elect Harris-Dawson, Chairs and members of the HHC, PWC and PSC; and Councilmembers Yaroslavsky, Park and Hutt:

The Westside Regional Alliance of Councils (WRAC) is a cooperative coalition of all 14 neighborhood and community councils on the Westside of Los Angeles, in Council Districts 5 and 11 and portions of Council Districts 4 and 10. Our Alliance collectively represents over 500,000 housed and unhoused Angelenos.

Since January 2022, WRAC has taken multiple positions in support of the use of Sec. 41.18 (with offers of housing and services) to address encampments which threaten public health and safety in numerous public right of way (PROW) areas in our Westside neighborhoods. Specifically, we support 41.18 designation of PROW areas by our Councilmembers, in coordination with WRAC member councils; 41.18 designation of PROW areas near schools and libraries; and extension of 41.18 to restrict vehicle dwelling in PROW areas near sensitive uses. In June 2024, in connection with a related Council File (21-0329-S4), we reiterated our support for 41.18 and requested that the City Council support its retention and continued application and enforcement.¹

WRAC member councils appreciate that 41.18 has been used effectively in several Westside areas to ease unsafe and unhealthy conditions and to assist our unhoused neighbors. As a result, a majority (8) of WRAC's member councils have passed the following motion, or modified versions in keeping with its spirit:

“The Westside Regional Alliance of Councils (WRAC) opposes the motion in CF 21-0329-S5, which makes implementation of LAMC Sec. 41.18 unnecessarily and unreasonably complicated and needlessly involves county agencies in city policy. We agree with the protection of sensitive use sites and deem this Municipal Code section to be a necessary tool for combatting the proliferation of homelessness and protecting public health and safety citywide.* WRAC therefore strongly supports LAMC Sec. 41.18, which has been effectively implemented in Council District 11 and other areas of

For these reasons, we respectfully urge you to disapprove the motion in CF 21-0329-S5.
