

**Grant Expenditure Plan by Grant Award**

The California Cannabis Equity Act of 2018 established by Senate Bill 1294 (Equity Act) and the Budget Act of 2019, Item 1111-490 – Reappropriation (Budget Act of 2019) appropriated funding for the State to provide to local jurisdictions to develop and operate local cannabis equity programs that focus on the inclusion and support of individuals in California's legal cannabis marketplace who are from communities negatively or disproportionately impacted by cannabis criminalization. Resources made available through the California Cannabis Equity Grant support specific programs within the Social Equity Program.

**California Local Equity Grant Bureau of Cannabis Control Grant 2019**

In 2019, the State of California made \$10 million available to local jurisdictions in support of their social equity programs. DCR applied on behalf of the City of Los Angeles and was awarded \$1,834,156.38 from the California Bureau of Cannabis Control in 2019. Consistent with the California Equity Grant's 'eligible uses', from this grant, DCR has allocated grant resources in the following manner: \$1 million to support DCR's Social Equity Entrepreneur Development Grant Program ("SEED Grant Program"); \$650,740 for social equity individual applicant verification waivers (\$597 SEIA Eligibility Verification (Section 104.06.1) fee waiver per grantee); and \$183,416 for administrative costs related to SEP Management.

**California Cannabis Equity Grant Go-Biz 2020**

In 2020, the State of California made 30 million available to local jurisdictions in support of their social equity programs. DCR applied on behalf of the City of Los Angeles and was awarded \$6,042,014.00 from the Governor's Office of Business and Economic Development (GO-Biz) Cannabis Equity Grant for Local Jurisdictions 2020. Consistent with the California Equity Grant's 'eligible uses', from this grant, DCR has allocated grant resources in the following manner: \$5 million for DCR's SEED Grant Program; \$375,000 to administer the SEED Grant Program, \$392,014 for social equity individual application verification waivers ((\$597 SEIA Eligibility Verification (Section 104.06.1) fee waiver per grantee)) and \$275,000 to cover staff salaries related to SEP Management.

**California Cannabis Equity Grant Go-Biz 2021**

DCR received \$2,030,997 from GO-BIZ in 2021. From this grant, DCR will allocate the following amounts: \$1,624,997 in support of the SEED Grant Program \$203,000 in support of Business, Licensing & Compliance Technical Assistance; and \$203,000 to cover staff salaries.
