The actual historic sites of the 16 lynchings and 3 men shot should be geographically accurate as far as memorial placement is concerned and not annexed solely to El Pueblo for the city's convenience. WHEREAS, The elected representatives of the Lincoln Heights Neighborhood Council are aware that a small bronze plaque on the sidewalk already exists and it is not a suitable memorial to commemorate the worst lynching in US history that decimated 10% of the Chinese population of El Pueblo/Old Chinatown in 1871.
