Ordinance No. 187306

An ordinance amending Sections 200.121, and 200.125 of Article 10 of Chapter XX of the Los Angeles Municipal Code to remove malls and shopping centers from the definition of covered location, clarify that the article applies to individuals 12 years of age and older, authorize the Department of Building and Safety to issue citations, require businesses to post a notice of correction or administrative citation, and make other technical changes.

DO ORDAIN AS FOLLOWS:
Section. 1. Subsection C of Section
200.121 of Chapter XX of the Los
Angeles Municipal Code is amended to

C. City Facility means the Indoor Portion of any building, structure, or premises belonging to or under the control of the

City. Sec. 2. 200.121 Sec. 2. Subsection D.3 of Section 200.121 of Chapter XX of the Los Angeles Municipal Code is amended by deleting the phrase "malls, shopping centers

Sec. 3. Subsection H of Section 200.121 of Chapter XX of the Los Angeles Municipal Code is amended to read as

follows:

H. Individual Eligible for a COVID-19

Vaccine means a person 12 years of age
or older for whom a COVID-19 vaccine is
authorized for use by the FDA, including by way of an emergency use authorization or, in the case of a foreign visitor or traveler, a person 12 years of age or older for whom a COVID-19 Vaccine is authorized by the WHO.

Sec. 4, Subsections C and D are added to Section 200.125 of Chapter XX of the Los Angeles Municipal Code to read as

Angeles Municipal Code to read as follows:

C. An operator of a Covered Location or Outdoor Large Event shall display any notice to correct or Citation issued

notice to correct or Citation issued pursuant to this section in a prominent location at the entrance of the establishment for 30 days.

D. The Department of Building and Safety, or any authorized enforcement officer, is authorized to issue Citations as set forth in this active. set forth in this article.

Sec. 5. Urgency Clause. The City Council finds and declares that this ordinance is required for the immediate protection of the public peace, health, and safety for the following reasons: Clarifying and updating the requirements of the ordinance requiring proof of COVID-19 vaccination in certain locations, which became effective November 8, 2021, is a subject of imminent concern. To promote the health and safety of the residents and

subject of imminent concern. To promote the health and safety of the residents and employees of the City of Los Angeles, this ordinance must become effective as soon as possible. For all these reasons, the ordinance shall become effective upon publication pursuant to Los Angeles Charter Section 253.

Sec. 6. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main

Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
