The Patient Self Determination Act (PSDA) of 1990 ensures that a patient's right to self-determination in health care decisions is communicated and protected. It guarantees competent adults the right to accept or reject medical or surgical treatment. (1) Medical mandates of experimental drugs that have no long-term studies violate the Nuremberg Code, which states the following: "The voluntary consent of the human subject is absolutely essential. This means that the person involved should have the legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved, as to enable him to make an understanding and enlightened decision." No long-term studies exist that show the vaccines to be safe. In fact, the current vaccines have shown themselves under the current emergency use authorization to be unsafe. The CDC maintains a database, the Vaccine Adverse Event Reaction System (VAERS), that already shows over 12,000 deaths (2, 3) from Covid vaccines. A whistleblower data scientist with access to Medicare data declared that the number of deaths is at least 45,000 (4).
