Vaccine mandates violate fundamental human rights, notably the right to prior, free and informed consent for medical interventions. In a free society, everyone should have complete power and control over their own bodies. I urge you to do all in your power to ensure a return to the democratic principles upon which this country was founded. Should employers/schools be able to mandate a medical procedure to their employees and then not pay for an injury should it happen? Though vaccines injure and fail in real-world conditions, legislation passed in 1986 left U.S. children and adults with a striking absence of legal protections from vaccine injury. Why expect people to take on all of the risk of injury and lost wages when vaccine manufacturers don't back their products?
