Comments for Public Posting: Nearly a month has passed since this motion on Mar. 9. Please consider a number of large, successful companies who have stated ("Who's Requiring Workers to Be Vaccinated?" New York Times, 2/23/22) they do not plan to require vaccination of their employees: Home Depot, Bank of America, Intel, Proctor & Gamble, Macy's, Autoliv, State Farm, Borg Warner, PPG, Lumen, DuPont, Southern Company, Duke Energy, Fortune Brands Home & Security, Nationwide, PG&E, Cornerstone Building Brands, Sanderson Farms. Five other companies stated they will allow testing as an alternative to vaccination for certain employees: Dell, Liberty Mutual, Leidos, Gannett American Family Insurance. Also, after the Supreme Court shot down Biden's OSHA "mandate" in January, Starbucks decided to drop their plan to require vaccination or weekly testing for employees (CNBC, 1/19/22).
