

ORDINANCE NO. 188453

An ordinance amending Section 12.04 of the Los Angeles Municipal Code by amending the zoning map.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The Zoning Map, as provided in Los Angeles Municipal Code (LAMC) Section 12.04, for the properties shown in the Maps, attached as Hillside Construction Regulation "HCR" District Zone Change Maps (1 through 4) to this Ordinance and incorporated herein by this reference, is amended by changing the zone classifications as provided in the "Table for Section 1," below.

Sec. 2. A property shown in the Maps attached as Hillside Construction Regulation "HCR" District Zone Change Maps (1 through 4) is subject to the Hillside Construction Regulation "HCR" Supplemental Use District regulations in Los Angeles Municipal Code Section 13.20, including as it may be amended from time to time.


Sec. 3. **OPERATIVE DATE.** This ordinance shall be operative on February 11, 2025 to comply with the rezoning program deadline of February 12, 2025.

Sec. 4. **URGENCY CLAUSE.** The City Council finds and declares that this ordinance is required for the immediate protection of the public peace, health and safety

because this ordinance is necessary for urgently needed housing. As recognized in the Housing Element, the City has a need for the development of approximately 450,000 housing units by the year 2029, including an immediate need of tens of thousands of units to serve an existing shortfall. In order to address this shortfall, the City must complete a rezoning program by February 12, 2025 pursuant to California Government Code 65583(c)(1)(A), at which time a determination of non-compliance could trigger a significant loss of funding for housing and infrastructure, loss of local zoning control, and court-imposed fines. This potential loss of funding for housing could result in less affordable housing being developed citywide, posing a severe threat to the stability of lower income households and further contributing to the City's ongoing homelessness and affordable housing crisis. This ordinance implements a rezoning program that would make the City compliant with state-mandated requirements. For these reasons, this ordinance shall become effective upon publication pursuant to Section 253 of the Los Angeles City Charter.










