Members of the City of Los Angeles Planning and Land Use Committee:

*Fix the City, Inc, Hollywoodian's Encourage Logical Planning (HELP), SaveHollywood.org, and the La Mirada Avenue Neighborhood Association were Petitioners/Plaintiffs in the **LA Superior Case No. 138580** and they were on the prevailing side of Judge Goodman's decision, which was decided and finalized on February 11, 2014.*

Judge Alan Goodman's tentative and final decision are incorporated by reference in these comments.

As a stakeholder and a member of two of these organizations in the above referenced case we object to the Hollywood Community Plan Update and the EIR associated with CF 21-0934.

We point to the binding ruling against the City of Los Angeles issued by Judge Goodman, and we furthermore draw your attention to Judge Goodman's Tentative Decision in the case which details the standards from the court by which this 2023 Community Plan Update supposed to be reviewed.
