DRAFT ORDINANCE AMENDING SECTIONS 104.01, 104.03, 104.06, 104.06.1, AND 104.20 OF ARTICLE 4 OF CHAPTER X OF THE LOS ANGELES MUNICIPAL CODE TO REGULATE COMMERICAL CANNABIS ACTIVITY

Honorable Members:

Pursuant to your request, this Office has prepared and now transmits for your consideration the enclosed draft ordinance, approved as to form and legality. The draft ordinance amends Sections 104.01, 104.03, 104.06, 104.06.1 and 104.20 of Article 4, Chapter X of the Los Angeles Municipal Code (LAMC) to incorporate numerous changes related to commercial cannabis businesses, including:

- Amends the definition "Owner" to establish a City definition that does not rely on the State's cannabis regulations;
- Amends the definition of "Primary Personnel" to accommodate the new definition of "Owner";
- Clarifies when an Application or modification request may be abandoned for failure to timely submit payment, forms or documents;
- Creates a refiling process to allow Applicants with applications deemed abandoned to submit a new Application within a specified time period under certain conditions:

- Clarifies the administration of an application lottery to issue retail licenses;
- Establishes processing timelines to ensure both Applicants and the Department of Cannabis Regulation move Applications towards licensure in an efficient and timely manner;
- Clarifies that an Applicant or Licensee may continue to qualify under the Social Equity Program if either a successor in interest or surviving spouse inherits the Social Equity Individual Applicant's ownership interest; and
- Creates a standalone Social Equity Applicant Entity Verification process that may, at the Applicant's option, occur earlier in the licensing process.
