**PROPOSED AMENDMENT OF CONTRACTS FOR LEGAL SERVICES WITH
BEVERIDGE & DIAMOND PC RELATED TO THE JULY 11, 2021, FLOODING
INCIDENT AT THE HYPERION WATER RECLAMATION PLANT –
*MECKLENBURG v. CITY OF LOS ANGELES, ABDELNUR v. CITY OF
LOS ANGELES, AND KONIG v. CITY OF LOS ANGELES***

Honorable Members:

Pursuant to California Government Code Section 54956.9(d)(1), (d)(2), and (e)(1), this Office wishes to meet in closed session to discuss the need for term extensions and additional funding for its outside counsel contracts as detailed below. Government Code Section 54956.9 requires the issuance of a public statement that includes the section subdivision that authorizes the closed meeting, and that the closed session is being held to confer or discuss with, or receive advice from, legal counsel regarding exposure to litigation. This request for closed session relates to outside counsel's representation of the City of Los Angeles (City) in regulatory enforcement matters as well as civil and administrative matters that pertain to the July 11, 2021, flooding incident at the Bureau of Sanitation's Hyperion Water Reclamation Plant, including pending personal injury litigation (*Mecklenburg v. Hyperion Water Reclamation Plant*, LASC Case No. 21 STCV28114), mass tort litigation (*Abdelnur v. City of Los Angeles*, LASC Case No.

22STCV00153 and *Konig v. City of Los Angeles*, LASC Case No. 22STCV00970), and, based on existing facts and circumstances, a separate matter involving the significant exposure to litigation.

This Office puts forth the following recommendations for the City Council's consideration:

1. Approve an amendment to Contract No. C-140018 with Beveridge & Diamond that extends its term to January 15, 2029, and increases the contract ceiling by \$2.7 million, for a total contract amount of \$5.95 million.
2. Approve an amendment to Contract No. C-139942 with Beveridge & Diamond that extends its term to January 15, 2029, and increases the contract ceiling by \$430,000, for a total contract amount of \$5.13 million.
3. Authorize the City Attorney or designee to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the Chief Administrative Officer, and authorize the Controller to implement the instructions.

The Bureau of Sanitation (LASAN) will pay for this amended contract from LASAN special funds, and LASAN supports this recommendation. Therefore, we ask that the matter be placed on the closed session agendas of the Budget and Finance Committee and City Council as soon as practicable.
