

The Board of the Studio City Neighborhood Council (SCNC) supports Council File: 21-1209 Title Volunteer Emergency Medical Corps Establishment / Preventative Medical Services / Non-Emergency Street Medical Services / Unhoused Residents. Given the large number of trained medical professionals in the area, it makes total sense to have the City Administrative Officer, with the assistance of the Los Angeles Fire Department, be directed to report back to the City Council with recommendations on the establishment of a volunteer emergency medical corps for the City of Los Angeles, to provide medical services to persons experiencing homelessness. This will improve the quality of life for the unhoused, and reduce the number of 911 calls and emergency room visits where many homeless persons receive their primary medical care.
