Ordinance No. 187456
An ordinance amending Los Angeles
Municipal Code Sections 187.02 and
187.03 to correct references relating to
minimum wage provisions.

THE PEOPLE OF THE CITY OF LOS ANGELES

DO ORDAIN AS FOLLOWS:

Section 1, Subsection D of Section
187.02 of the Los Angeles Municipal
Code is amended to read as follows:

D. On July 1, 2022, and annually
thereafter, the minimum wage will
increase based on the Consumer Price
Index for Urban Wage Earners and
Clerical Workers (CPI-W) for the Los
Angeles metropolitan area, which is
published by the Bureau of Labor
Statistics. The DAA shall announce the
adjusted rates on February 1st and publish
a bulletin announcing the adjusted rates,
which shall take effect on July 1st of each
year.

Sec. 2. Subsection B of Section 187.03 of
the Los Angeles Municipal Code is
amended by deleting the reference to
"10.31.1(h)" and replacing it with
"10.25.1(l)";

Sec. 3. The City Clerk shall certify to the
passage of this ordinance and have it
published in accordance with Council
policy, either in a daily newspaper
circulated in the City of Los Angeles or by
posting for ten days in three public places
in the City of Los Angeles: one copy on
the bulletin board located at the Main
Street entrance to the Los Angeles City
Hall, one copy on the bulletin board
located at the Main Street entrance to the
Los Angeles City Hall East, and one copy
on the bulletin board located at the
Temple Street entrance to the Los
Angeles County Hall of Records.
