WHEREAS, on December 29, 1902, the first Korean immigrants to the United States – 56 men, 21 women, and 25 children – began their voyage across the Pacific Ocean; and

WHEREAS, the arrival of these first Korean immigrants on January 13, 1903 is just part of the history we need to remember and commemorate on this day; and

WHEREAS, Between 1904 and 1907, approximately 1,000 Korean American entered the United States mainland from the State of Hawaii through San Francisco, where the first Korean American political organizations and Korean language publications were established; and

WHEREAS, for more than a century Korean Americans have helped build, protect, and strengthen the United States, despite facing tremendous adversity, including discrimination and injustice, and threats of violence, to try to keep them on the fringes of American society; and

WHEREAS, Koreans have emerged from the fringes, moving from a position of vulnerability to one of empowerment and engagement; and

WHEREAS, Korean Americans have been and remain part of the indelible fabric of Los Angeles, contributing to the City's proud history, heritage, economic strength, and rich cultural diversity; and

WHEREAS, Los Angeles is currently home to largest population of Korean Americans in the entire United States, with more than 250,000 Korean Americans; and

WHEREAS, in 2005, the United States Senate and House passed resolutions by unanimous consent expressing support for the goals and aspirations of Korean American Day, also celebrated by numerous states and municipalities:

NOW THEREFORE, BE IT RESOLVED, that by adoption of this resolution, the City of Los Angeles does hereby declare January 13, 2022 KOREAN AMERICAN DAY in the City of Los Angeles.
