

WHEREAS, forty years ago, on Thursday, March 25, 1982, eighty four (84) Filipino American employees from various Department of the City of Los Angeles, spearheaded by Larry Rivera of the Community Development Department, and Cres Abad of the Personnel Department, convened at the Council Chambers and unanimously approved the creation of an association that advocated for the Filipino-American City employees, now known as the Los Angeles Filipino Association of City Employees, fondly known as LAFACE; and

WHEREAS, it is the mission and policy of LAFACE to: foster the advancement of Filipino Americans and all employees in City service, and nurtures collaborations with other minority groups and extends assistance to organizations in promoting the economic, social, cultural and educational advancement of Filipino Americans and all City employees; and

WHEREAS, LAFACE, assists and develops City Employees for promotional advancement by conducting civil service exam preparation trainings, leadership seminars, employment outreach, and various other educational presentations; and

WHEREAS, LAFACE provides leadership and networking opportunities for its members and all City employees through events and activities that utilize skills and talents, and where they can engage LA City directors and managers, community leaders and other organizations; and

WHEREAS, LAFACE continues to enrich the cultural and social fabric of Los Angeles by organizing cultural events, such as the Philippine Independence Day every June, the Filipino American History Month every October, hosting annual gatherings showcasing Filipino American food and hospitality and, engaging the Filipino community through various efforts; and

WHEREAS, LAFACE awards scholarships to high school and college students, to promote educational advancement:



RESOLUTION

WHEREAS, we take great pleasure in congratulating Detective II [REDACTED], upon his retirement, effective February 28, 2023, from the Los Angeles Police Department after 27 ½ years of dedicated and distinguished service to the People of Los Angeles and the Los Angeles Police Department; and

WHEREAS, Detective [REDACTED] was born on [REDACTED] in Dallas, Texas and later would grow-up in Fort Thomas, Kentucky, where he attended Highlands High School and graduated in 1983. After a short stint at Miami University in Oxford, Ohio where he studied business, he left school and moved to Los Angeles to pursue a career in production in the music, film and TV industries. [REDACTED] toured with the artists Al Jarreau, Marlboro Country Music and the rock band Ratt as a rigger and carpenter. In the early 1990's he worked at Covenant House in Hollywood on an outreach team member serving homeless youth. This is where [REDACTED] developed an interest in Law Enforcement; and

WHEREAS, [REDACTED] began his career with the Los Angeles Police Department on September 5, 1995, when he entered the Los Angeles Police Academy, and began serving with honor in the following assignments, Training Division as a Recruit; Rampart Area where he began to develop his skills as a street Police Officer; Van Nuys and then onto 77th Area, where he continued to hone his street skills, in the Specialized Enforcement Unit, then to Hollywood Division where on August 25, 2002, Officer [REDACTED] was promoted to Police Officer III. He was now responsible for the training of new patrol officers and to develop these young officers patrol skills. On June 1, 2003, Officer [REDACTED] was selected to become an element member in the highly coveted Metropolitan Division "Charlie" Platoon and was selected into the Mounted "Edward" Platoon. While assigned to Metropolitan Division he volunteered and was selected to join the Department's Underwater Dive team, [REDACTED] continued to develop skills and went on to become a certified rescue diver and an Emergency Medical Technician, EMT-1, [REDACTED] was selected to become part of the Mayor's security detail; and on July 13, 2014, was promoted to Detective I assigned to Olympic Area Detectives, where he continued to develop his investigative skills, while assigned to Auto and Robbery investigations, on October 4, 2015, he was selected to be a member of Major Crimes Division, Jail Debrief Unit, where Detective [REDACTED] interviewed inmates regarding criminal intelligence; and

WHEREAS, on June 12, 2016, Detective [REDACTED] was promoted to Sergeant I and assigned to Olympic Area as a field supervisor, where he mentored young police Officers in daily field operations, on October 1, 2017, Sergeant [REDACTED] transferred to Southwest Area where he continued as a field supervisor guiding and mentoring patrol officers in Department procedures, policies and tactics. On August 5, 2018, Sergeant [REDACTED] decided to assist those with mental challenges and transferred to the Mental Evaluation Unit, where he assisted in some of the city's most challenging calls for service; and

WHEREAS, on April 14, 2019, Sergeant I [REDACTED] was promoted to Detective II, and was selected to become a member of the elite Special Investigation Section (S.I.S.) where he became only 1 of 127 individuals at the time to be assigned to this highly skilled and coveted unit. Detective [REDACTED] has been an integral part of the investigation and arrest of some of Southern California's most notorious criminal acts; the murder investigation of Los Angeles Police Officer Juan Diaz, the Lady Gaga kidnapping and the follow home Rolex robbers; and

WHEREAS, [REDACTED] has been an intricate part of the training in S.I.S. as a licensed EMT-1 for 12 years, his ideas and insight has allowed the Section to continue to be at the forefront when it comes to tactical medicine; and

WHEREAS, Detective II [REDACTED] has received over 90 commendations for outstanding actions from supervisors, commanding officers and Los Angeles residents as well as other local, state and federal law enforcement agencies; While assigned to the Special Investigation Section Detective [REDACTED] has made great sacrifices of himself and his family; missing family functions and special events to respond to the needs of the Department at the drop of a hat to arrest murderers and kidnappers and return other's loved ones to their families unharmed; and

RICK J. CARUSO

WHEREAS, Rick Joseph Caruso was born January 7, 1959 to Henry and Gloria Caruso. Rick's grandparents, Augusto and Josephine, immigrated to America separately as teenagers, both coming from Italy through Ellis Island. They met, fell in love, married and eventually settled in Boyle Heights in the late 1920s. Augusto worked as a gardener, operating from the back of his pickup truck and planting the seeds for four thriving generations of family. At their regular Sunday dinners, Rick's grandmother relentlessly emphasized the importance of hard work, honoring the family name, keeping faith and giving back to their community; and

WHEREAS, Caruso's father, Henry, attended Marshall High, served in World War II and then attended the University of Southern California on the G.I. Bill. He achieved great early success, but took a massive personal fall in his career when he was indicted and served time for fraud. Rick drew the ultimate lessons from his father's refusal to allow his mistakes to define him. Through his father, Rick learned the importance of redemption, and the value of offering people a second chance. After this setback, Henry founded Dollar Rent-a-Car, one of the most successful car rental franchises in America; and

WHEREAS, growing up, Rick attended Good Shepherd Grammar School, served as an altar boy and graduated from Harvard High. He received his bachelor's degree from USC in 1980 and a law degree from Pepperdine in 1983, where he was later named Alumnus of the Year; and

WHEREAS, Rick and his wife, Tina, established the Caruso Loan Forgiveness Fund which covers the law school loan payments for ten years for low-income and other underserved students. In October 2019, he donated \$50 million to Pepperdine School of Law, which was renamed in his honor. The gift is directed to historically underrepresented students as well as to students pursuing public interest law; and

WHEREAS, Caruso founded the Caruso Family Foundation, which focuses on organizations that improve the lives of children in need of healthcare and education; and

WHEREAS, Rick and his wife, Tina have been married for 35 years and are the proud parents of four children: Alex, Gregory, Justin, and Gianna:

WHEREAS, Carmine was born on August 19, 1938, as Carmine Joseph Tuberosi on the Island of Ischia off the coast of Naples, Italy to Vittorio and Josephine Tuberosi. Vittorio was a commercial fisherman and Josephine a housewife; and

WHEREAS, in 1948, the family moved to Mar De Plata, Argentina in search of a better life. Vittorio continued commercial fishing and Carmine began commercial fishing as well. To help the family, Carmine also took a job at a Bakery in Mar De Plata. In 1966, the family was granted entrance to the USA and migrated to San Pedro, CA. Carmine took all the money that the family had and started Joseph's Bakery; and

WHEREAS, Rosa Tuberosi was born Rosa Pesce on February 2, 1946, in Ischia to Giorgio and Cristina Pesce. Giorgio was a commercial fisherman and Christina a housewife. Rosa and her family migrated to the USA in November of 1963, settling in San Pedro, as well. Giorgio continued as a commercial fisherman. Rosa, her mom and her two older sisters began work as seamstresses at Chic Lingerie in Redondo Beach; and

WHEREAS, the Pesce's lived within walking distance of the newly opened Joseph's Bakery, and Rosa would often go to buy baked goods for her family. Carmine was quickly drawn to Rosa but was shy and had trouble mustering the courage to ask her out. One day when he knew she was coming, he prepared himself a special courage-inducing drink, whiskey. After two quick shots he had the courage to ask Rosa out. After months of dating the two were married on August 2, 1969, at Mary Star of the Sea Church; and

WHEREAS, in 1970, Rosa gave birth to a son, Victor, and in 1972, another son, George was born. Rosa and Carmine ran Joseph's Bakery themselves until Victor and George were old enough, at which time they joined their parents working at the family business; and

WHEREAS, Victor is married to Livia DiOrio, and they have two sons, Joseph and Vincent. George is married to Samantha Zar and they also have two sons, Matthew and Michael. The four cousins all help out at the bakery, and will hopefully, someday take over the business and continue the family tradition well into the future; and

WHEREAS, Joseph's Bakery has now been open for 56 years and has become a San Pedro Institution:
