RESOLUTION

WHEREAS, World AIDS Day was the first ever global health day, held for the first time in 1988; and

WHEREAS, the theme of this year's World AIDS Day is "Equalize" and the inequalities which perpetuate the AIDS pandemic are not inevitable; we can tackle them. This World AIDS Day, 1 December, UNAIDS is urging each of us to address the inequalities which are holding back progress in ending AIDS. The "Equalize" slogan is a call to action; and

WHEREAS, it is a prompt for all of us to work for the proven practical actions needed to address inequalities and help end AIDS, including: increase availability, quality and suitability of services, for HIV treatment, testing and prevention, so that everyone is well-served; reform laws, policies and practices to tackle the stigma and exclusion faced by people living with HIV and by key and marginalized populations, so that everyone is shown respect and is welcomed; ensure the sharing of technology to enable equal access to the best HIV science, between communities and between the Global South and North; support communities to make use of and adapt the "Equalize" message to highlight the particular inequalities they face and to press for the actions needed to address them; and

WHEREAS, only one-third of people in key populations—including gay men and other men who have sex with men, transgender people, people who use drugs, sex workers, and prisoners—have regular prevention access, and key populations face major legal barriers including criminalization, discrimination and stigma; and

WHEREAS, the social determinants of health that drive HIV rates include homelessness, substance use, and mental health and these issues are consistently addressed by HIV prevention programs funded by the AIDS Coordinator's Office. Program achievements include: providing services to over 35,000 unduplicated clients, including syringe collection of more than 2 million used syringes, conducted over 7,000 naloxone trainings to people at risk of overdose; and

WHEREAS, the AIDS Coordinator's Office has been a leader in developing innovative programs for marginalized and hard-to-reach populations, and we look to the future to expand the HIV and homelessness program, continue HIV and Disability Legal Services Partnership that will provide pro-bono legal services in collaboration with the LA County Bar Association, certify a new Syringe Exchange Providers, and integrate COVID response to allow service providers to adapt services; and

WHEREAS, we have only eight years left before the 2030 goal of ending AIDS as a global health threat. Economic, social, cultural and legal inequalities must be addressed as a matter of



urgency. In a pandemic, inequalities exacerbate the dangers for everyone. Indeed, the end of AIDS can only be achieved if we tackle the inequalities which drive it.
