**WHEREAS,** Gloria was back to square one, having to start over completely from scratch; she decided to get back on the horse and began searching for stables, horses and volunteers, and even volunteering herself for the first 18 months as she worked to create the therapeutic horsemanship organization we now know as Ride On; and

**WHEREAS,** Gloria would go on to work with children and adults with mental and physical disabilities for over 30 years, using the movement of the horse to improve the medical conditions of individuals through occupational and physical therapy; and

**WHEREAS,** in February of 2017, Ride On surpassed 100,000 lessons since the conception of the organization, growing by around 7,000 lessons per year to over 225 individuals with disabilities; and


**WHEREAS,** Gloria is a three time coach of the US Paralympic Equestrian team in Atlanta and also serves as a judge at the Special Olympics World Games; and

**WHEREAS,** she is a not only a leader, but a teacher and mentor to countless professionals who she has inspired with her dedication and wealth of knowledge, which has helped to create more dedicated leaders in the therapeutic riding field; and

**WHEREAS,** Gloria will forever be the one who started it all, and as the heart and soul of Ride On her dedication, drive, and commitment to the organization is a major factor in all of its successes and triumphs; and

**NOW, THEREFORE BE IT RESOLVED,** that by adoption of this resolution, the Los Angeles City Council hereby commend Gloria Hamblin for her decades of service helping to improve the quality of life of individuals with disabilities in our community. We wish her health and happiness with continued success in all of her future endeavors.

WHEREAS, Fernando Navarrete was born in Acapulco, Mexico and immigrated to the United States at age 5, settling in the Wilmington community; and

WHEREAS, Fernando has always kept a positive and humble outlook on life despite difficult life challenges inspiring those around him; and

WHEREAS, Fernando has served as an active community member in Wilmington through his role as a Chicano Youth Leadership Facilitator, International Trade Education Programs Advisory Board and an Advisory Resident Committee member, overseeing multiple projects in partnership with local business owners and other community-based organizations; and

WHEREAS, after years of living as an undocumented immigrant, Fernando applied for and was granted legal status under the Obama administration's Deferred Action for Childhood Arrivals (DACA) program; and

WHEREAS, Fernando became a vocal advocate for immigration reform and worked to achieve permanent legal status for all "Dreamers;" and

WHEREAS, Fernando began working as a community organizer with I Heart Wilmington, where his advocacy and activism quickly impressed the Council District 15 staff; and

WHEREAS, Fernando began his service as the Wilmington Field Deputy to Councilmember Joe Buscaino on August, 16, 2017; and

WHEREAS, Fernando was a fierce advocate for the Wilmington community, and constantly fought to ensure Wilmington received its fair share of City services; and

WHEREAS, Fernando took ownership of the Wilmington Municipal Building and put in blood, sweat and tears to bring long needed improvements to the building; and

WHEREAS, Fernando brought three new parks to Wilmington including East Greenbelt Community Park; and

WHEREAS, Fernando brought CicLAvia to Wilmington three times during his five year tenure with the council office; and

WHEREAS, Fernando takes supporting local businesses seriously by always having very frequent "meetings" at Ambrosia Coffee House, Sirens, and Hojas Tea House, and will officially bring outdoor dining parklets to Wilmington; and

### Guatemalan Day

WHEREAS, with an estimated population of around 18 million, Guatemala is the most populated country in Central America. Guatemala is rich in resources, culture and history. The core of the Mayan civilization, which extended across Mesoamerica, was historically based in the territory of modern Guatemala.

WHEREAS, in the 1960's civil unrest and discontent began to grow amongst Guatemalan civilians against the Guatemalan government. By the late 1970's and early 1980's there was a massive exodus of Guatemalans fleeing Civil War in Guatemala.

WHEREAS, the Pico Union, Westlake and MacArthur Park area of Los Angeles became the epicenter of Guatemalan refugees. Some Guatemalans left Los Angeles and resettled in other cities across the United States. But most remained in the City of Los Angeles.

WHEREAS, this exodus of newly arrived Guatemalan war refugees created a new workforce within the City of Los Angeles. The Guatemalan community found employment in the restaurant industry, hotel and hospitality industry, and the garment industry. The Guatemalan-Mayan community was key in the financial success of the garment industry in Los Angeles.






