WHEREAS, he became an academic and obtained a Bachelor's Degree in Civil Engineering, Masters of Science in Hydraulic Engineering, and a Ph.D. in Hydraulic and Water Resources Engineering; and

WHEREAS, after receiving his doctorate, he served as the Dean and CEO of Arbaminch Water Technology Institute where he oversaw six facilities, over 100 academic staff, and more than 5,000 students; and

WHEREAS, in 2004, he was appointed as the Regional Representative and Head for International Water Management Institute (IWMI) sub-regional office for Nile Basin and Eastern Africa, where he was able to support and engage in projects on surface and groundwater; irrigation, crop and livestock; energy, technology, policy and institutions; decision support and much more; and

WHEREAS, from 2010 to 2014, he worked for the African Climate Policy Center (ACPC) of UNECA as Senior Water and Climate Change Specialist establishing the work areas of water, climate science and information, agriculture, green economy, and energy; and

WHEREAS, he later served as the Senior Inter-Regional Advisor at the United Nations Department of Economic and Social Affairs (UNDESA), in the Division of Sustainable Development and Branch of Water, Energy and Capacity Development advising and integrating the 2030 Agenda for Sustainable Development into national strategies; and

WHEREAS, in 2016, he served as the Minister of Energy, Water, and Irrigation where he led major development portfolios that are directly accountable to the Prime Minister and Parliament; and

WHEREAS, from late 2021 to early 2022, he was the Advisor to the Prime Minister of Ethiopia, and Chief Negotiator of Transboundary Water and Grand Ethiopian Renaissance Dam (GERD) at a Minister level; and

WHEREAS, in 2022, Dr. Seleshi Bekele Awulachew was appointed as Ethiopia's new ambassador to the United States of America;

Whereas, Arturo serves as the CEO of NALEO, an affiliated national membership organization of Latino policymakers and their supporters, which is governed by a 36-member Board of Directors. Arturo has held these positions since 1994;

Whereas, before joining NALEO and NALEO Educational Fund, Arturo was Vice President for Community Education and Public Policy at the Mexican American Legal Defense and Educational Fund (MALDEF), where he supervised and directed MALDEF's community education and leadership development programs;

Whereas, Arturo previously held the position of Director of Outreach and Policy, where he coordinated MALDEF's 1991 redistricting efforts, which led to a historic increase in the number of Latinos serving in the California legislature;

Whereas, Arturo directed MALDEF's National 1990 Census Program, an award-winning national outreach and public policy effort to promote a full count of the Latino population;

Whereas, Arturo was the Senior Education Policy Analyst at the National Council of La Raza (NCLR – now known as UnidosUS in Washington, D.C;

Whereas, Arturo is also a nationally recognized expert in Latino demographic trends, electoral participation, voting rights, the census, and redistricting;

Whereas, he has served on numerous national, state, and local non-profit and foundation boards. Appointed by both Republican and Democratic U.S. Secretaries of Commerce, he previously served on various National Advisory Committees to the U.S. Census Bureau and the 2001–2002 and 2011–2012 Los Angeles City Council Redistricting Commissions;

Whereas, Arturo has received Hispanic magazine's Hispanic Achievement Award for Community Service, the National Federation of Hispanic Owned Newspapers' Leadership Award, the National Association for Bilingual Education President's Award, the City University of New York's Civic Leadership Award, Univision's Community Service Corazon Award, and the National School Board Association's Hispanic Caucus Abrazo Award;

Whereas, he has been included twice in Hispanic Business Magazine's List of 100 Hispanic Influentials and named one of the 101 most influential Latinos 10 times by Latino Leaders;
