Re: Municipal Lobbying Ordinance Updates - Council File 22-0560

Neighborhood Council Leaders demand a robust update to the municipal lobbying ordinance, which closes current loopholes and does not create new loopholes.

### **Background**

Forty-five Neighborhood Councils representing stakeholders across every City Council district have passed community impact statements demanding the advancement of the municipal lobbying ordinance (MLO), which has not undergone comprehensive reform since 1994. Twice before, in 2008 and 2016, recommendations from the Ethics Commission have died without a vote by the City Council. We will not accept this happening for a third time. Articles in the Los Angeles Times<sup>1</sup> and the Los Angeles Daily News<sup>2</sup> have highlighted the unprecedented campaign by Neighborhood Councils in support of a robust and enforceable MLO, which closes loopholes and does not open the door to new loopholes.

We thank the Ethics Commission for their work in crafting a revised municipal lobbying ordinance which took into account the call by Neighborhood Council Leaders for greater disclosure. We also thank the Board of Neighborhood Commissioners<sup>3</sup> and the Neighborhood Council Budget Advocates<sup>4</sup> for their support of our advocacy. Like noted good government advocates, "we believe that changes to the Ethics Commission's proposed updates are needed to ensure the City's MLO is effective in achieving its purpose of transparency, accountability, and a level civic playing field."<sup>5</sup> However, we have been disturbed by the reported push for carve outs by unions and nonprofits. These exemptions do not advance the public interest or the public trust.

## 501(c)(3) Exemption

At the time of the writing of this document, thirty two Neighborhood Councils have advocated for lowering the proposed 501(c)(3) exemption to align with the IRS 990-EZ filing. The current MLO provides a limited exemption for a 501(c)(3) organization "if it receives

government funding and provides direct representation services free of charge to indigent persons." The Ethics Commission recommended creating an additional exemption for any 501(c)(3) with gross receipts below \$2 million in the previous year. This proposal was intended to cater to small nonprofits, but captures many (if not most) of the large nonprofits that are active in advocacy at City Hall. In addition, a gross receipts model would allow bad actors to front load contributions in order to evade registering under the lobbying ordinance. 501(c)(3)s are able to remain IRS compliant if less than 20% of their initial expenditures are spent on lobbying efforts with a cap of \$1 million per year spent on lobbying. A blanket exemption for medium and large nonprofits invites special interests to create and utilize front groups to engage in lobbying, free from regulation under the MLO. "Real reform will be illusory if we simply close one loophole while creating a new one."

Some 501(c)(3)'s have raised the specter of the cost of compliance as a reason to oppose their inclusion within the MLO. As good governance advocates have so deftly pointed out, "it is important to note that compliance with our MLO in no way requires someone to hire a lawyer. Our Ethics Commission staff are extremely responsive and are available to answer any questions. They are often the first place that lawyers turn to for guidance. Anyone who is a lobbyist or has questions as to whether they might be a lobbyist can seek informal or formal advice from the Ethics Commission" without cost.<sup>8</sup>

The much-touted letter from SAJE<sup>9</sup> points to LAANE's \$30,000 fine by the Ethics Commission as a reason to not subject nonprofits to the MLO. However, the characterization of these events as a mistake, rather than as a willful disregard for the existing lobbying ordinance, is disingenuous. LAANE spent over \$175,000 on unregistered lobbying over the course of several years while filing reports that claimed \$0 in expenditures.<sup>10</sup> It strains credulity to assert the organization "reliably filed reports."

### 501(c)(5) Exemption

Neighborhood Council leaders are opposed to any introduction of a 501(c)(5) exemption for labor unions. Neighborhood Councils understand how power works in this City and that is why we have fought hard to advocate for disclosure and tightening of loopholes around the MLO. It is incomprehensible to Neighborhood Council Leaders that an exemption being pushed

by the Los Angeles County Federation of Labor would even be considered given that *this committee was only created due to the leaked Fed tapes*. The most powerful institutions should neither be demanding nor gaining exemptions over the general public. It is anathema to the call by Neighborhood Councils for a truly robust lobbying ordinance. Union lobbyists have unique interests aiming to deliver better City Contracts for their members which our elected officials often play a role in approving. Unlike small nonprofits, Labor has the resources to navigate public disclosure and compliance. Moreover, Labor has robust existing infrastructure to support staff engaged in lobbying, reducing any burden of compliance even further.

#### Conclusion

Hundreds of Neighborhood Council leaders representing over 1.6 million constituents have joined together to call for strong lobbying reforms. We are often the front line for some of the worst and most deceptive lobbying practices and we can speak most clearly to the necessity of these reforms. It is time for a lobbying ordinance that serves the people, not the special interests. This issue has united Neighborhood Council leaders across the political spectrum and across Council Districts.

We urge the committee to advance a new MLO that is both comprehensive and enforceable and that does not grant loopholes for special interests.
