## **Subject: A Bridge Home Funds Redistribution**

Honorable Members:

In response to the feedback received from your Committee, the Los Angeles Police Department (Department) is revising how the A Bridge Home (ABH) overtime funds are allocated for Fiscal Year (FY) 2022-23. This allocation reflects the updated list of ABH locations in each Council District provided by the Office of the Mayor. The Committee also requested an accounting of the Department's expenditure of discretionary funds for FY 2021-22.

### **Allocation of A Bridge Home funds across all Council Districts, FY 2022-23:**

As requested by Committee, the FY 2022-23 ABH funds will be allocated to each Council District in a base amount of 3,533 hours. An additional 1,000 hours per ABH location will be allocated to each Council District as reflected in Table 1. The Department recognizes those ABH locations designated by the Office of the Mayor, of which currently there are 27 recognized sites (Table 3).

### **Allocation of City Council discretionary funds across all Council Districts, FY 2021-22:**

In response to the Committee's request for information on Council discretionary funds received by the Department, Table 2 provides an accounting of funds received by Council District.
