An ordinance adding Subsection C to Section 11.5.8 of Article 1.5 of Chapter 1 of the Los Angeles Municipal Code to recognize the consolidation of the Central City Community Plan and the Central City North Community Plan areas into the new Downtown Community Plan area, and to update Los Angeles Municipal Code references from 35 to 34 community plan areas.

## THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Subsection C is added to Section 11.5.8 of Article 1.5 of Chapter 1 of the Los Angeles Municipal Code to read:

- C. After adoption of Subsections A and B, above, which were adopted by voter initiative in Ordinance No. 184,745, the City adopted the Downtown Community Plan Update, in compliance with the requirements of this section, to consolidate the Central City Community Plan and the Central City North Community Plan to the Downtown Community Plan. As such, notwithstanding the references in Subsections A and B, the City is divided into 36 planning areas and 34 community plan areas. Any references in the Code to the Central City Community Plan or the Central City North Community Plan shall mean the Downtown Community Plan.
- Sec. 2. **SEVERABILITY**. If any portion, subsection, sentence, clause or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance and each portion or subsection, sentence, clause and phrase herein, irrespective of the fact that any one or more portions, subsections, sentences, clauses or phrases be declared invalid.
  - Sec. 3. This ordinance shall be operative on January 27, 2025.

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
