

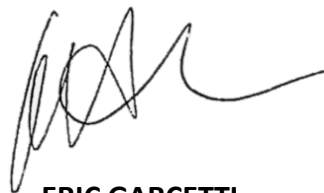

This donation is valued at \$138,300.00. The request is for a Roadrunner AFI4700 EFIS upgrade kit. This upgrade will improve operational safety and mission effectiveness by increasing situational awareness, improving operations in instrument meteorological conditions, enabling in-flight Global Positioning Satellite navigation, and reducing pilot workload. The package includes the installation kit, mounts, cables, other related accessories, and labor for the installation.

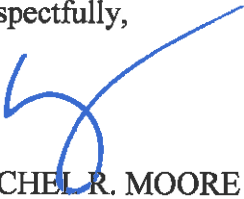

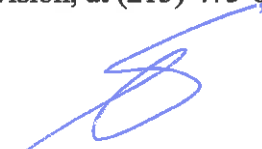
