ORDINANCE NO. 187589

An ordinance levying taxes and setting the tax rates for the several interest and sinking funds for bonded indebtedness of the City for the fiscal year beginning July 1, 2022, and ending June 30, 2023.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. There is hereby levied a tax upon taxable property in the City of Los Angeles (not including property taxable for State purposes only under the provisions of the Constitution or laws of the State of California) within the limits of Taxation District Nos. 1, 6, 11, 12, 13, 14, and 16, comprising the following portions of the City of Los Angeles:

Sec. 2. The names used in this ordinance to identify portions of the City of Los Angeles comprising the various taxation districts created in this ordinance, except "Original City," are, respectively, the names by which these portions of the City were designated in the proceedings by which the areas comprising these portions of the City of Los Angeles were, respectively, annexed to or consolidated with the City of Los Angeles; the name "Original City" used in this ordinance to identify a portion of the City of Los Angeles within Taxation District No. 1 refers to that portion of the City of Los Angeles within the boundaries of the City as fixed and described in Section 1 of the Charter of the City of Los Angeles of 1889, Statutes of 1889, Page 456.


Sec. 3. If any tax rate, section, clause, sentence, phrase, or portion of this ordinance is held invalid by any court or tribunal of competent jurisdiction, the remaining tax rates, sections, clauses, sentences, phrases, or portions of this ordinance shall remain in full force and effect, and to this end the provisions of this ordinance are severable.

Sec. 4. Pursuant to City Charter Section 252(b), this ordinance shall take effect upon its publication.

Sec. 5. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


