It has been a long journey to get to this final hearing. On May 6, 2021, I contacted the Office of Historic Resources about designating the historic house at 15526 Plummer Street an HCM. In August 2021, I met with the owner and presented our vision of the Plummer Street Project to restore the house, create a small museum and new park for the community. However, I am unable to celebrate because the owner, a real estate developer who doesn't live in our neighborhood, decided to sell the two properties to Brighstar. Brighstar's Valor Academy is planning on building another elementary school on the property and no one will be able to visit the HCM. It will be shut behind the school fences and the historic house will be used for offices. We have a better plan, one that we have presented to our neighborhood councils, to our councilpersons, to anyone who would listen. A plan that we call the Plummer Street Project. The North Hills community raised over \$5,000 to accomplish the designation, but we want the HCM to become a museum and the vacant land a new park for the entire community, not just the school children. We have been fighting hard to stop Valor Academy from building a new elementary school that we don't need. We already have 12 elementary schools in North Hills, but we only have one park. This is an ideal location for a park since there are no buildings to tear down. The community has offered to form a 501c3 non-profit organization to raise funds to restore the house and create the park. I have spoken to LA Parks and Recreation who would like to proceed. We want to work with our city leaders to do the right thing for the community. But it looks like our city representatives are ignoring us, in fact, shutting us out! Even though I subscribed to be notified of any hearings, and I should be notified since I am the Applicant, I was not notified of this meeting tomorrow January 25, 2023 at 10am. The only way I found out about the meeting tomorrow morning is I decided to email CD7 Monica Rodriguez's office this morning to see if there was an update on when the meeting would take place. Please I beg the City Council members to stop this Valor Academy project that we don't need and help us do the right thing. Create a park for the entire community! Let's restore the house and open it to
