Subject: The Guatemalan Square Community Renaming - Council File No. 22-1094

The Bureau of Engineering has reviewed the application submitted to change the community name of a neighborhood in Central Los Angeles. The application proposes renaming the neighborhood as The Guatemalan Square.

There are approximately 302 parcels with an estimated 7,659 people population derived from the 2020 census. This community is completely within Council District 1 and the Westlake Community Plan Area. The community is also part of the 90017 and 90057 zip codes, and the MacArthur Park and Westlake South Neighborhood Council Districts.

The attached maps show the parcels within the proposed new community borders as shown on the application in relation to the boundaries of the Council Districts, Community Plan Areas, Neighborhood Councils, Census Tracts, and zip codes.

The Bureau of Engineering has no additional pertinent information concerning the historical use for this neighborhood in the community.

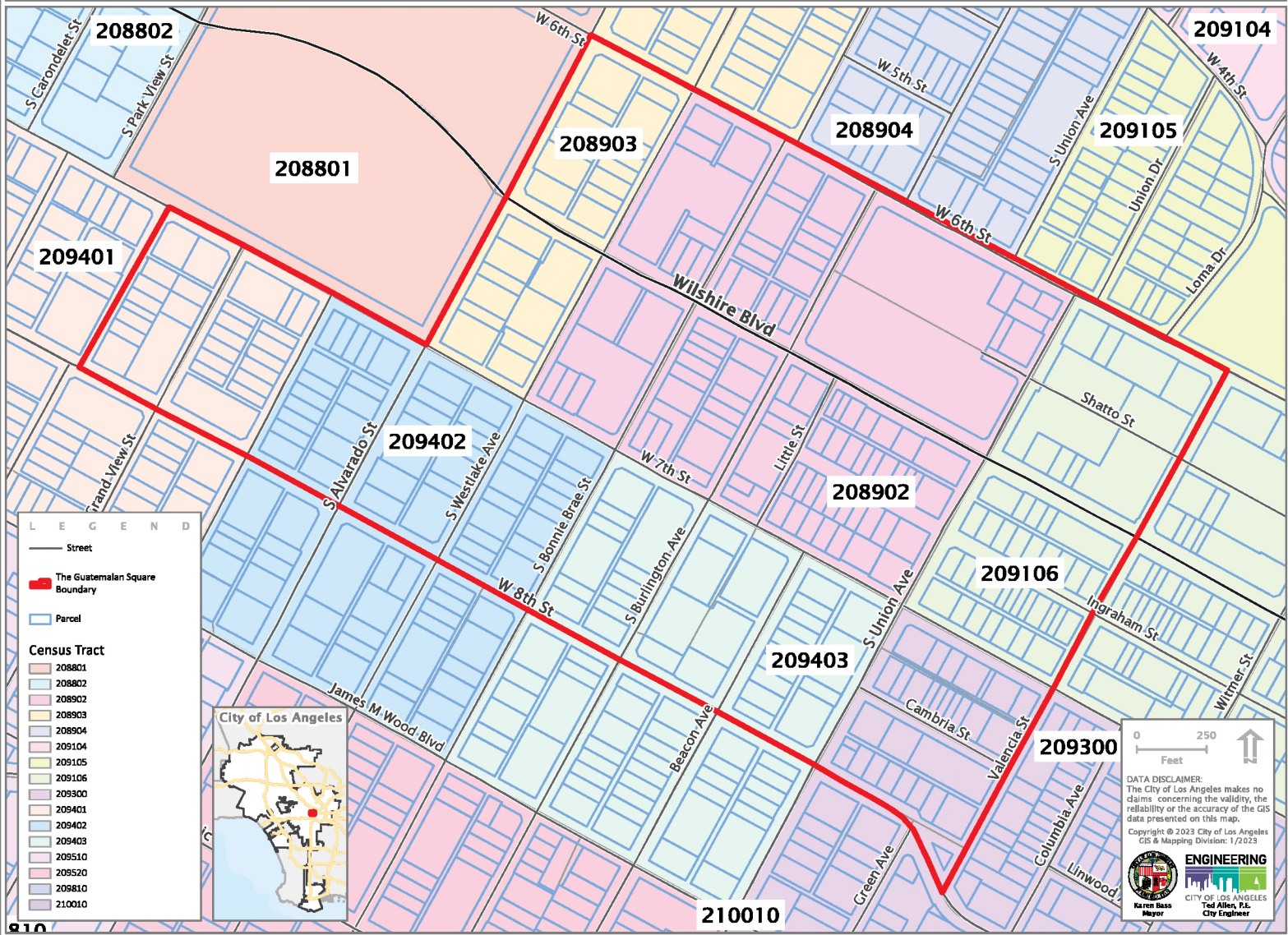

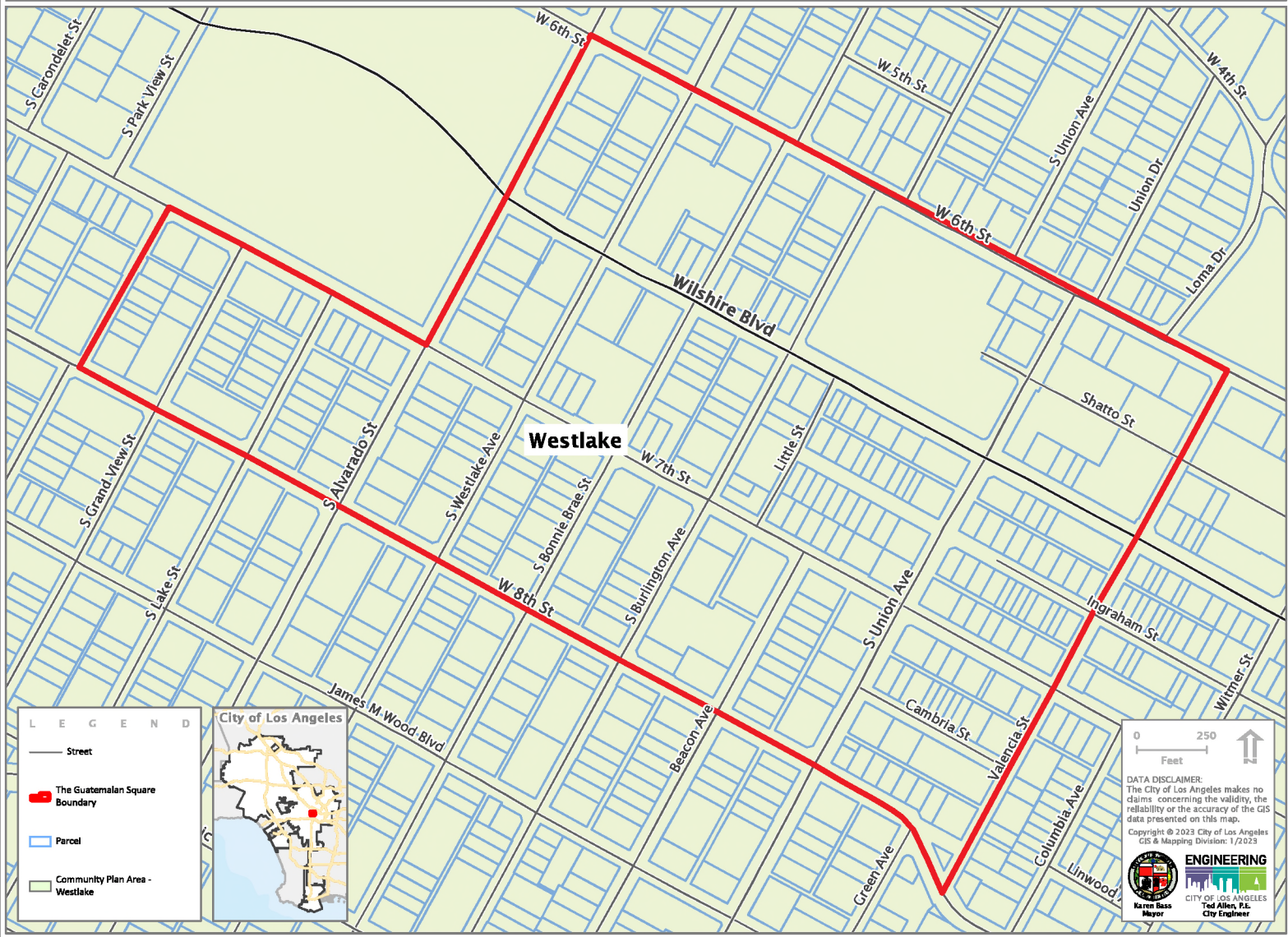

The Guatemalan Square Census Tracts



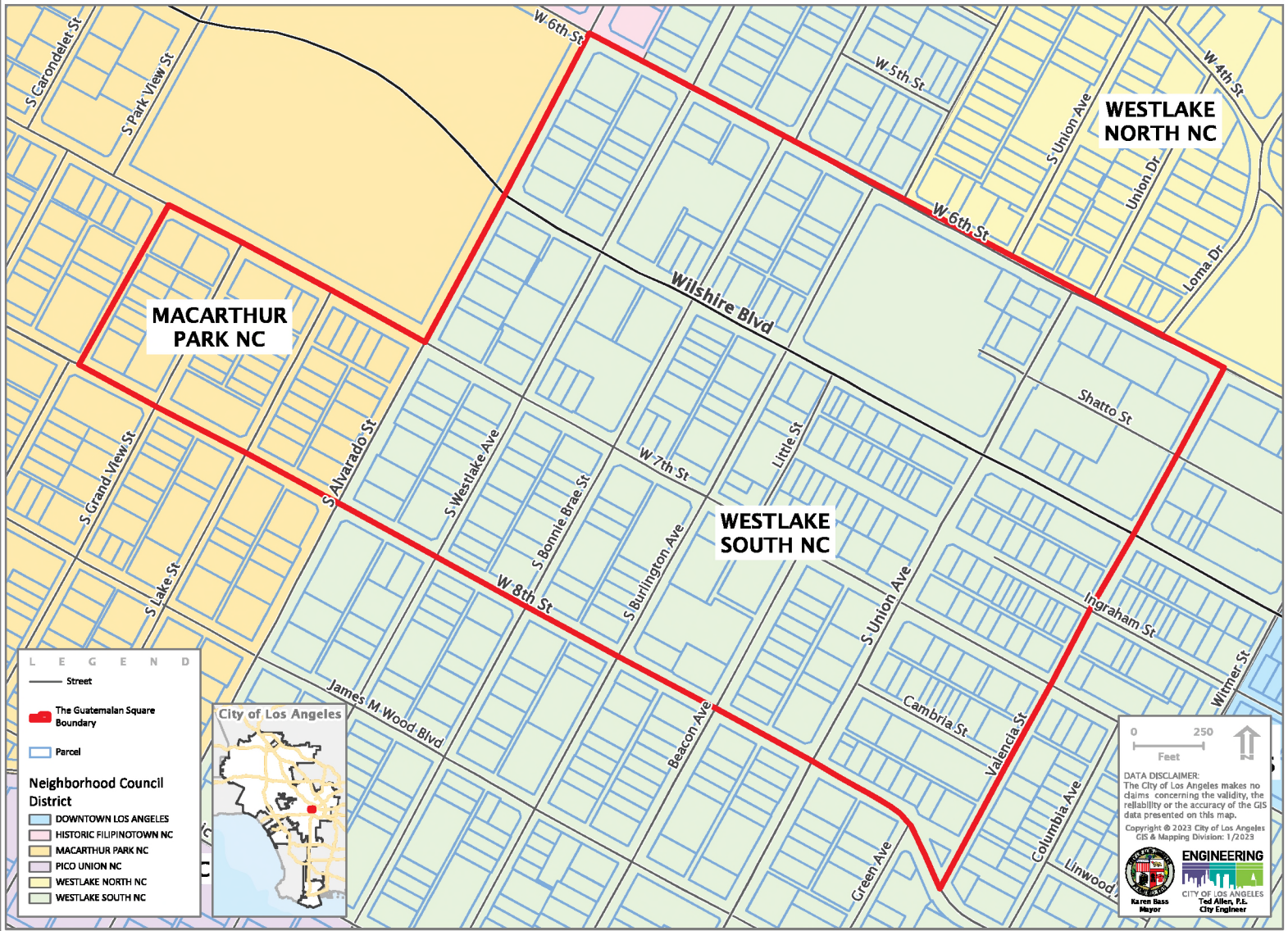
The Guatemalan Square Community Plan Area
