Re: Notification of Request for Authority to Accept a Grant Award in the amount of \$300,000 from the Department of Justice (DOJ) for the Central District of California's (CDCA) Project Safe Neighborhood (PSN) Grant Program and Adoption of a Resolution (C.F. XX-XXX)

Dear Honorable Members:

Pursuant to Section 14.6(c) of the Los Angeles Administrative Code, the Mayor's Office of Gang Reduction and Youth Development ("GRYD Office") hereby notifies the Los Angeles City Council of its award of funding from the Department of Justice (DOJ) for the Central District of California's (CDCA) Project Safe Neighborhood (PSN) grant program in support of the comprehensive GRYD strategy.

Transmitted herewith for consideration by the City Council is a request to accept the funding in the amount of \$300,000 with a performance period of September 30, 2022 to September 30, 2023, and approval of the proposed budget for the PSN grant.

Background

Project Safe Neighborhoods (PSN) is designed to create and foster safer neighborhoods through a sustained reduction in violent crime, including, but not limited to, addressing criminal gangs and the felonious possession and use of firearms. The program's effectiveness depends upon the ongoing coordination, cooperation, and partnerships of local, state, tribal, and federal law enforcement agencies--and the communities they serve--engaged in a unified approach led by the U.S. Attorney (USA) in all 94 districts. The City submitted an application on February 12, 2021, explaining the City's current crime data and its intent to fund the GRYD Surge Community Ambassador Program in

response to the surge of gun violence in LAPD's Southeast Division. Subsequently, on March 24, 2021, the City was awarded the PSN Grant.

A. GRYD Surge Community Ambassador Program

The PSN funds will be used to fund the Surge Community Ambassador Program within the GRYD service areas in LAPD's Southeast Area. This program will enhance and supplement the City-funded gang intervention efforts in the area and complement the LAPD's Law Enforcement Purpose Area proposal submitted for their work in the same community.

The GRYD Surge Community Ambassador Program will allocate funds to hire seven (7) Surge Community Ambassadors. The overall goal of the Surge Community Ambassador Program is to provide strategic gang intervention and peacemaking as well as triage referrals to gang intervention and reentry case management services. The additional ambassadors will cover gangs or gang sets that are not currently covered by current intervention contracts, can reach younger more active members or in the case of larger gangs, additional ambassadors to expand access to that gang. Ambassadors for gangs that typically operate outside the City border but impact violence in Southeast through traditional rivalries may be identified and funded through the grant.

The Mayor's Office requests authority to negotiate and execute contracts with Community Partners to be the sub-recipient of the Surge Community Ambassador Program in an amount not to exceed \$278,430 for a contract performance period, September 30, 2022 to September 30, 2023, and (Please see contract budget allocation per grant year in Section D, "Budget").

During the PSN grant funding cycle, the GRYD Office intends to allocate \$278,430 for seven Surge Community Ambassadors during the grant performance period. Said funding will support with conducting violence interruption and crisis response activities to specific gang-related confrontations services. Surge Community Ambassadors will respond to the crime scene, hospital, family home and community to create pathways/connections that aid in reducing tensions and building peace. The funding allocation also supports events, trainings, supplies and equipment, and indirect costs.

B. Program Implementation Costs

The following GRYD staff will be required to implement the PSN grant:

A) Program Director (Mayoral Aide VII, Step 3)

Fringe in the amount of \$6,237 will be allocated to these positions, for a total salaries and benefits allocation of \$15,333.

The Program Director will manage day to day coordination of the grant and provide grant oversight to this project. The Program Manager will be responsible for grant administration and will serve as the primary point of contact. They shall also be responsible for ensuring that the project implementation plan is adhered to, project objectives are met, and reports are submitted according to the timeline determined by DOJ. The Grant and Training Coordinator will support the management of the day to day coordination of the project, along with the submission of grant and data reports, and provide assistance to the Program Manager.

D. Budget

The following budget was presented in the grant application and approved by the DOJ.

E. Reserve Fund Loan

The Mayor's Office requests approval of a Reserve Fund advance in the amount of \$200,000 to facilitate cash flow and immediate disbursement to service providers contracted to implement the Surge Community Ambassador Program in the LAPD Southeast Division and GRYD service areas under the PSN Grant Program. DOJ administers the PSN Grant on a reimbursement basis only, requiring grant recipients to front-fund expenditures prior to submitting requests for reimbursement. The Mayor's Office plans to submit requests for reimbursement on a quarterly basis (as allowed by the grantor) to facilitate repayment of the Reserve Fund advance, with full repayment by the end of the grant performance period in 2023.

RECOMMENDATIONS

IT IS THEREFORE requested that the City Council:

1. **AUTHORIZE** the Mayor, or designee, to accept the 2020 Project Safe Neighborhoods (PSN) Grant award from the Department of Justice in the amount of \$300,000, for the period effective September 30, 2022 to September 30, 2023;
2. **AUTHORIZE** the Mayor, or designee, to negotiate and execute the Grant Award Agreement and submit any other necessary agreements and documents relative to the grant award, subject to the review and approval of the City Attorney as to form and legality;
3. **ADOPT** the attached governing body resolution which endorses the grant agreements and agrees to comply with the program and funding requirements of the grant;
4. **AUTHORIZE** the Mayor, or designee, to negotiate and execute contracts with Community Partners to be the sub-recipient of the Surge Community Ambassador Program in the Southeast Division and GRYD Zones respectively, for the period of September 30, 2022 to September 30, 2023, in an amount not to exceed \$278,430 for a two-year contract performance period, subject to the approval of the City Attorney as to form and legality and compliance with City contracting requirements;
5. **AUTHORIZE** the Controller to:

Establish a new fund entitled 2020 PSN. Recognize a receivable in the amount of \$300,000 within the 2020 PSN grant, Fund XXX, Department 46; expend funds upon presentation and proper demand from the Mayor, or designee, and establish appropriation accounts as follows:

6. **INSTRUCT** the Controller to transfer up to \$15,333 from Fund XXX, Account 46W146 to the Mayor's General Fund No. 100, Department 46, Account 001020 for reimbursement of grant-funded personnel salaries;
7. **INSTRUCT** the Controller to transfer up to \$6,237 from Fund XXX, Account 46W299 to the Mayor's General Fund No. 100, Department 46, Account 5346 for reimbursement of grant-funded fringe benefits;
8. **AUTHORIZE** a Reserve Fund Loan in the amount of \$200,000 to support program-related activities under the 2020 PSN Grant, which is to be repaid by the Office of the Mayor at the end of the fiscal year.
9. **AUTHORIZE** the Controller to transfer \$200,000 from the Reserve Fund to the Unappropriated Balance Fund No. 100/Dept 58 and transfer therefrom to the 2020 PSN Grant Fund XXX Dept 46; and
10. **AUTHORIZE** the Mayor, or designee, to prepare Controller instructions and/or make technical adjustments that may be required to implement the actions approved by the Mayor and Council on this matter, subject to the approval of the City Administrative Officer and authorize the Controller to implement these instructions.

2. Applicability of Part 200 Uniform Requirements

5. Required training for Point of Contact and all Financial Points of Contact

Both the Point of Contact (POC) and all Financial Points of Contact (FPOCs) for this award must have successfully completed an "OJP financial management and grant administration training" by 120 days after the date of the recipient's acceptance of the award. Successful completion of such a training on or after January 1, 2018, will satisfy this condition.

9. Employment eligibility verification for hiring under the award

any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.

E. Nothing in this condition, including in paragraph 4.B., shall be understood to relieve any recipient, any subrecipient at any tier, or any person or other entity, of any obligation otherwise imposed by law, including 8 U.S.C. 1324a(a)(1) and (2).

48. The recipient agrees to submit to DOJ for review and approval, any proposal or plan for Project Safe Neighborhoods media-related outreach. DOJ approval must be received prior to any obligation or expenditure of grant funds related to the development of media-related outreach projects.
49. PSN Fiscal Agent Definition

References in this award document to “recipient” and “fiscal agent” both refer equally to the entity or organization receiving this award directly.
50. The recipient understands and agrees that no more than 10 percent of the total amount of this award may be used by the recipient for costs associated with administering the award.
51. Required monitoring of subawards

The recipient must monitor subawards under this award in accordance with all applicable statutes, regulations, award conditions, and the DOJ Grants Financial Guide, and must include the applicable conditions of this award in any subaward. 52. No use of funds to interfere with federal law enforcement: information-communication restrictions; ongoing compliance

1. Throughout the period of performance, no State or local government entity, -agency, or -official may use funds under this award (including under any subaward, at any tier) to prohibit or in any way restrict-- (1) any government entity or -official from sending or receiving information regarding citizenship or immigration status to/from DHS; or (2) a government entity or -agency from sending, requesting or receiving, or exchanging information regarding immigration status to/from/with DHS, or from maintaining such information. Any prohibition (or restriction) that violates this condition is an "information-communication restriction" under this award.

2. The recipient's monitoring responsibilities include monitoring of subrecipient compliance with the requirements of this condition.

3. Allowable costs. Compliance with these requirements is an authorized and priority purpose of this award. To the extent that such costs are not reimbursed under any other federal program, award funds may be obligated for the reasonable, necessary, and allocable costs (if any) that the recipient, or any subrecipient at any tier that is a State, a local government, or a public institution of higher education, incurs to implement this condition.

4. Rules of Construction

A. For purposes of this condition:

(1) "State" and "local government" include any agency or other entity thereof (including any public institution of higher education), but not any Indian tribe.

(2) A "public" institution of higher education is defined as one that is owned, controlled, or directly funded (in whole or in substantial part) by a State or local government. (Such a public institution is considered to be a "government entity," and its officials to be "government officials.")

(3) "Program or activity" means what it means under title VI of the Civil Rights Act of 1964 (see 42 U.S.C. 2000d-4a).

(4) "Immigration status" means what it means under 8 U.S.C. 1373 and 8 U.S.C. 1644; and terms that are defined in 8 U.S.C. 1101 mean what they mean under that section 1101, except that "State" also includes American Samoa.

(5) "DHS" means the U.S. Department of Homeland Security.

B. Nothing in this condition shall be understood to authorize or require any recipient, any subrecipient at any tier, any State or local government, any public institution of higher education, or any other entity (or individual) to violate any federal law, including any applicable civil rights or nondiscrimination law.

53. Authority to obligate award funds contingent on no use of funds to interfere with federal law enforcement: information-communication restrictions; unallowable costs; notification

1. If the recipient is a "State," a local government, or a "public" institution of higher education:

A. The recipient may not obligate award funds if, at the time of the obligation, the "program or activity" of the recipient (or of any subrecipient at any tier that is a State, a local government, or a public institution of higher education) that is funded in whole or in part with award funds is subject to any "information-communication restriction."

B. In addition, with respect to any project costs it incurs "at risk," the recipient may not obligate award funds to reimburse itself if -- at the time it incurs such costs -- the program or activity of the recipient (or of any subrecipient, at any tier, described in paragraph 1.A of this condition) that would be reimbursed in whole or in part with award funds was subject to any information-communication restriction.

C. Any drawdown of award funds by the recipient shall be considered, for all purposes, to be a material representation by the recipient to OJP that, as of the date the recipient requests the drawdown, the recipient and each subrecipient (regardless of tier) described in paragraph 1.A of this condition, is in compliance with the award condition entitled "No use of funds to interfere with federal law enforcement: information-communication restrictions; ongoing compliance."

D. The recipient must promptly notify OJP (in writing) if the recipient, from its requisite monitoring of compliance with award conditions or otherwise, has credible evidence that indicates that the funded program or activity of the recipient, or of any subrecipient (at any tier) described in paragraph 1.A of this condition, may be subject to any information-communication restriction. In addition, any subaward (at any tier) to a subrecipient described in paragraph 1.A of this condition must require prompt notification to the entity that made the subaward, should the subrecipient have such credible evidence regarding an information-communication restriction.

2. Any subaward (at any tier) to a subrecipient described in paragraph 1.A of this condition must provide that the subrecipient may not obligate award funds if, at the time of the obligation, the program or activity of the subrecipient (or of any further such subrecipient at any tier) that is funded in whole or in part with award funds is subject to any information-communication restriction.

3. Absent an express written determination by DOJ to the contrary, based upon a finding by DOJ of compelling circumstances (e.g., a small amount of award funds obligated by the recipient at the time of a subrecipient's minor and transitory non-compliance, which was unknown to the recipient despite diligent monitoring), any obligations of award funds that, under this condition, may not be made shall be unallowable costs for purposes of this award. In making any such determination, DOJ will give great weight to evidence submitted by the recipient that demonstrates diligent monitoring of subrecipient compliance with the requirements set out in the "No use of funds to interfere ... information-communication restrictions; ongoing compliance" award condition.

4. Rules of Construction

A. For purposes of this condition "information-communication restriction" has the meaning set out in the "No use of funds to interfere ... information-communication restrictions; ongoing compliance" condition.

B. Both the "Rules of Construction" and the "Important Note" set out in the "No use of funds to interfere ... information-communication restrictions; ongoing compliance" condition are incorporated by reference as though set forth here in full.

54. Requirement to collect certain information from subrecipients

Except as provided in this condition, the recipient may not make a subaward to a State, a local government, or a "public" institution of higher education, unless it first obtains from the proposed subrecipient responses to the questions identified in the program solicitation as "Information regarding Communication with the Department of Homeland Security (DHS) and/or Immigration and Customs Enforcement (ICE)." All subrecipient responses must be collected and maintained by the recipient, consistent with document retention requirements, and must be made available to DOJ upon request. Responses to these questions are not required from subrecipients that are either a tribal government/organization, a nonprofit organization, or a private institution of higher education.

55. With respect to this award, federal funds may not be used to pay cash compensation (salary plus bonuses) to any employee of the award recipient at a rate that exceeds 110% of the maximum annual salary payable to a member of the federal government's Senior Executive Service (SES) at an agency with a Certified SES Performance Appraisal System for that year. (An award recipient may compensate an employee at a higher rate, provided the amount in excess of this compensation limitation is paid with non-federal funds.)

This limitation on compensation rates allowable under this award may be waived on an individual basis at the discretion of the OJP official indicated in the program announcement under which this award is made.

56. PSN Withholding: Application Attachment

The recipient may only obligate, expend, and draw down \$15,000 for the sole purpose of attending a required OJP conference/ meeting associated with this grant award. Recipient may not obligate, expend or draw down funds until (1) it has provided to the grant manager for this OJP award the required application attachment(s), (2) OJP has completed its review of the information provided and of any supplemental information it may request, and (3) a Grant Adjustment Notice has been issued removing this special condition. Recipient should further be aware that the provisions found herein may be superseded by more restrictive special conditions otherwise placed upon this award.

57. Recipient integrity and performance matters: Requirement to report information on certain civil, criminal, and administrative proceedings to SAM and FAPIIS

The recipient must comply with any and all applicable requirements regarding reporting of information on civil, criminal, and administrative proceedings connected with (or connected to the performance of) either this OJP award or any other grant, cooperative agreement, or procurement contract from the federal government. Subject: Categorical Exclusion for The Children's Initiative

The FY 20 Project Safe Neighborhoods Initiative, represents a strategic approach that brings more “science” into criminal justice operations by leveraging innovative applications of analysis, technology, and evidence-based practices with the goal of improving performance and effectiveness while containing costs while addressing crime associated with gun crime and gang violence. Awards under this program will implement the five core elements of PSN— partnerships, strategic planning and research integration, training and technical assistance outreach, and accountability, data analysis, and data-informed efforts —to address specific gun crime and gang violence problems in that district.

None of the following activities will be conducted either under the OJP federal action or a related third party action:

- 1) New construction;
- 2) Any renovation or remodeling of a property either (a) listed on or eligible for listing on the National Register of Historic Places or (b) located within a 100-year flood plain;
- 3) A renovation which will change the basic prior use of a facility or significantly change its size;
- 4) Research and technology whose anticipated and future application could be expected to have an effect on the environment; or
- 5) Implementation of a program involving the use of chemicals.

Consequently, the subject federal action meets OJP's criteria for a categorical exclusion as contained in paragraph 4(b) of Appendix D to Part 61 of the Title 28 of the Code of Federal Regulations. Additionally, the proposed action is neither a phase nor a segment or a project which when viewed in its entirety would not meet the criteria for a categorical exclusion.
