The Voices Neighborhood Council on October 18, 2022 voted unanimously to SUPPORT, City Council File 22-1189 on the resolution to resolve that Councilmembers Nury Martinez, Kevin De Leon and Gil Cedillo are CENSURED for their conduct and statements during the referenced meeting of October 2021, and the Council joins the Los Angeles community in demanding their immediate resignation from the Council.

We unequivocally condemn the anti-Black, anti-Indigenous, homophobic, anti-Semitic, and violent comments made by people that have been elected to represent those exact communities they are disparaging.

Words matter, so we want to make sure that we are clear that this will not be tolerated anywhere in our community. We strive to be inclusive and welcoming and as we continue to grow our coalition, we want to make sure that those tasked with representing us at the highest level are held to a higher standard. Because these representatives have failed to do so, we seek their immediate resignations. We cannot allow our taxpayer dollars to continue to be used to fund those who behind closed doors can spew such rhetoric and pretend that their words have no impact on their actions and how they govern our city.

We thank you for your attention to this matter and appreciate your commitment to strengthen our community.
