Re: Council File 22-1189: Call for Resignation of Councilmembers Kevin de León and Gil Cedillo

Dear Council President Krekorian, President Pro Tempore Price and Councilmembers:

The Westside Regional Alliance of Councils (WRAC) is an alliance of all fourteen Neighborhood and Community Councils on the Westside of Los Angeles, located in CDs 5 and 11 and portions of CDs 4 and 10.

Members of our Alliance are deeply offended by the blatant racism and grossly unprofessional conduct displayed by former Councilmember Martinez and Councilmembers de León and Cedillo, as reflected in secretly recorded discussions and widely reported in news media, and have joined with the City Council and community in expressing their outrage.

A supermajority (nine) of WRAC member Councils (all members that have taken up the matter to date) have accordingly passed motions or resolutions calling for the immediate resignation of Councilmembers de León and Cedillo: Bel Air-Beverly Crest Neighborhood Council; Del Rey Neighborhood Council; Mar Vista Community Council; Neighborhood Council Westchester/Playa; North Westwood Neighborhood Council; Pacific Palisades Community Council; Venice Neighborhood Council; Westside Neighborhood Council; Westwood Neighborhood Council.

It is therefore the adopted position of WRAC that Councilmembers Kevin de León and Gilbert Cedillo should resign their positions. **WRAC calls on each of them to resign immediately.**
