Dear Council President Krekorian, President Pro Tempore Price and Councilmembers:

The Westside Regional Alliance of Councils (WRAC) follows up on our original position letter in this matter (<https://westsidecouncils.com/wp-content/uploads/2022/10/WRAC-letter-re-CM-Resignations.pdf>), by advising you that *three additional member Councils* of our Alliance have also expressed their outrage at the racist and unprofessional conduct displayed by former Councilmembers de León and Cedillo, and have joined with other members of WRAC in passing motions calling for their resignation.

As a result, **12 of 14 WRAC member Councils** (all members that have been able to take up the matter to date) have passed motions or resolutions calling for the resignation of Councilmembers de León and Cedillo: Bel Air-Beverly Crest Neighborhood Council; Del Rey Neighborhood Council; Mar Vista Community Council; Neighborhood Council Westchester/Playa; North Westwood Neighborhood Council; Pacific Palisades Community Council; South Robertson Neighborhoods Council; Venice Neighborhood Council; West LA-Sawtelle Neighborhood Council; Westside Neighborhood Council; Westwood Community Council; Westwood Neighborhood Council.

WRAC again calls on Councilmembers Kevin de León and Gilbert Cedillo to resign immediately.
