**RECOMMENDED ACTIONS**

1. That the Board of Police Commissioners (Board) REVIEW and APPROVE this report.
2. That the Board TRANSMIT the attached grant application and award, pursuant to Administrative Code Section 14.6(a), to the Mayor, Office of the City Administrative Officer (CAO), Office of the Chief Legislative Analyst, and the City Clerk for committee and City Council consideration.
3. That the Board REQUEST the Mayor and City Council to:
  - A. AUTHORIZE the Chief of Police to retroactively apply for and ACCEPT the grant award of \$128,234.95 for the 2022 Bulletproof Vest Partnership (BVP) Grant from the Bureau of Justice Assistance, United States Department of Justice, for the period of April 1, 2022 to August 31, 2024;
  - B. AUTHORIZE the Controller to set up a grant receivable and appropriate \$128,234.95 to appropriation account, account number to be determined, within Fund No. 339, Department No. 70, for the receipt and disbursement of BVP Grant funds;
  - C. AUTHORIZE the Los Angeles Police Department (LAPD) to submit grant reimbursement requests to the grantor and deposit the grant receipts in Fund No. 339, Department No. 70;
  - D. AUTHORIZE the LAPD to spend up to the total grant amount of \$128,234.95 in accordance with the grant award agreement;
  - E. AUTHORIZE the LAPD to prepare the Controller's instructions for any necessary technical adjustments, subject to the approval of the CAO, and instruct the Controller to implement the instructions.

**DISCUSSION**

The LAPD has been a recipient of the BVP Grant for over 15 years. Because of grant funding, LAPD has been able to purchase National Institute of Justice compliant armored vests for police officers. The Department of Justice, Bureau of Justice Assistance, will reimburse the Department fifty percent of the cost of each vest purchased up to a total amount of \$128,234.95. The grant will provide funding for approximately 356 new or replacement vests. The Department has participated in the BVP Program for over 15 years with total funding over \$3.5 million.

Awards will not be extended past that date, and any unused funds will be forfeited.

The [Bureau of Justice Assistance \(BJA\)](#) is pleased to announce the Fiscal Year (FY) 2022 [Patrick Leahy Bulletproof Vest Partnership \(BVP\) program](#) application funding period. The purpose of the BVP program is to reimburse states, counties, federally recognized tribes, cities, and local jurisdictions up to 50% of the cost of body armor vests purchased for law enforcement officers. Applications for FY 2022 BVP funds will be accepted beginning Thursday, April 28, 2022. All applications must be submitted online at [Patrick Leahy Bulletproof Vest Partnership: Login \(usdoj.gov\)](#) by **6:00 pm eastern time on Monday, June 27, 2022**.

### **Important Information regarding FY 2022 BVP:**

- 1. System for Award Management (SAM) Registration Requirement:** Jurisdictions will not be able to apply for and receive FY 2022 BVP funds if they are not registered in SAM. Jurisdictions not registered with SAM are strongly encouraged to access the SAM website at <http://www.sam.gov> as soon as possible in order to obtain information on and to complete the online SAM registration. Applicants should ensure that current bank routing and bank account information is included in the [www.sam.gov](http://www.sam.gov) profile, as the banking information in the SAM at the time of application will be used to transfer reimbursement funds to your jurisdiction. For more information about renewing and updating your existing SAM registration, or registering in SAM as a new entity, please visit [www.sam.gov](http://www.sam.gov). - 2. Unique Entity Identifier (UEI):** SAM recently transitioned from the DUNS number to the new Unique Entity Identifier (UEI). 4. **Mandatory Wear Policy:** Jurisdictions receiving funding for reimbursement of body armor purchases must have a written mandatory wear policy for uniformed patrol officers in place when the FY 2022 BVP applications are submitted. There are no requirements regarding the nature of the policy other than it specify when mandatory wear is required for uniformed officers on duty. 5. **Compliant Vest Lists:** Each vest purchased with FY 2022 funds must meet the National Institute of Justice (NIJ) standards on the date it was ordered and must be American-made. Please see this website for the latest NIJ compliant vests: <https://cjtec.org/compliance-testing-program/compliant-product-lists/>.
6. **Uniquely Fitted Armor Vest Requirement:** Jurisdictions receiving funding for reimbursement of body armor purchases must have in place a uniquely fitted vest requirement when the FY 2022 BVP applications are submitted. In the BVP Program, "uniquely fitted vests" means protective (ballistic or stab-resistant) armor vests that conform to the individual wearer to provide the best possible fit and coverage, through a combination of: 1) correctly-sized panels and carrier, determined through appropriate measurement, and 2) properly adjusted straps, harnesses, fasteners, flaps, or other adjustable features. The requirement that body armor be "uniquely fitted" does not necessarily require body armor that is individually manufactured based on the measurements of an individual wearer. In support of the Office of Justice Programs' efforts to improve officer safety, the American Society for Testing and Materials (ASTM) International has made available the *Standard Practice for Body Armor Wearer Measurement and Fitting of Armor* ([Active Standard ASTM E3003](#)) available at no cost. The [Personal Armor Fit Assessment checklist](#), is excerpted from ASTM E3003.
7. **Eligibility:** Multiple law enforcement agencies (LEAs) within the same jurisdiction must submit their own application information and vest needs to the jurisdiction. The jurisdiction will then submit the LEA applications in one submission to BJA. This includes colleges and universities. All public colleges and universities are considered LEAs under their respective jurisdiction.
8. **Items to Review:** To ensure that program participants are submitting applications that accurately reflect their vest needs for the next two years, please review the program guidance below. Prior to submitting an application for FY 2022 BVP funds:
  - Verify that the number of vests indicated on the application does not exceed actual agency needs. Review all currently deployed vests for those that will need to be replaced during the next two years, according to the replacement cycle indicated on your BVP system profile. Applications for funds should reflect the number of vests your agency needs to replace within the next two years, and vests for officers your agency anticipates hiring in the next two years. (New hires can be anticipated based on the average number of officers hired over the most recent three years.)
  - Ensure that the application accurately reflects the current market cost for the vests identified on the application.
  - Review previous year(s) BVP funding to identify any unspent funds that might currently be available for BVP needs.

**Funding Decisions and Notification:** When this application period closes, the following will occur: Each application is checked against the availability of funds to cover a portion of its total cost, in keeping with established rules and statutory set-asides. Once funding decisions are made, Congress is notified, followed by an electronic (email) message to the primary jurisdiction contact regarding the specific level of funding available. After this notification, DOJ requires additional time to create or update each jurisdiction's financial account. Asset forfeiture funds may also be used to meet the jurisdiction's financial requirement.
