**RECOMMENDED ACTIONS**

1. That the Board of Police Commissioners (Board) REVIEW and APPROVE this report.
2. That the Board TRANSMIT the attached grant application and award, pursuant to Administrative Code Section 14.6(a), to the Mayor, Office of the City Administrative Officer (CAO), Office of the Chief Legislative Analyst, and the City Clerk for committee and City Council consideration.
3. That the Board REQUEST the Mayor and City Council to:
  - A. AUTHORIZE the Chief of Police to retroactively APPROVE the grant application and ACCEPT the grant award of \$1,000,000 from the Bureau of Justice Assistance, United States Department of Justice for the FY 2022 Body-Worn Camera Policy and Implementation Program to Support Law Enforcement Agencies Grant – Category 3: Digital Evidence Management and Integration Demonstration Projects (FY22 BWC – Digital Evidence) for the period of October 1, 2022 to September 30, 2025;
  - B. AUTHORIZE the Chief of Police or his designee to execute the grant agreement, subject to the review of the City Attorney as to form and legality;
  - C. AUTHORIZE the Chief of Police or his designee to execute a new contract or amend an existing agreement with Axon Enterprise, Inc. for centralization and integration of all digital evidence, not to exceed \$250,000 for the performance period of October 1, 2022 to September 30, 2025, subject to the approval of the City Attorney;
  - D. AUTHORIZE the Chief of Police or his designee to execute a new contract or amend an existing contract with a vendor for provision of services as the research partner and evaluator of the program, not to exceed \$250,000 for the performance period of October 1, 2022 to September 30, 2025, subject to the approval of the City Attorney;

- E. AUTHORIZE the Los Angeles Police Department (LAPD) to spend up to the total grant amount of \$1,000,000 in accordance with the grant award agreement;
- F. AUTHORIZE the LAPD to submit grant reimbursement requests to the grantor and deposit the grant receipts in Fund No. 339, Department No. 70;
- G. AUTHORIZE the Controller to set up a grant receivable and appropriate \$1,000,000 to appropriation account, account number to be determined, within Fund No. 339, Department No. 70, for the receipt and disbursement of FY22 BWC-Digital Evidence grant funds;
- H. AUTHORIZE the Controller to increase appropriations as needed for FY22 BWC-Digital Evidence from Fund No. 339, Department No. 70, account number to be determined, to Fund No. 100, Department No. 70, account numbers and amounts as follows:

## DISCUSSION

In August 2015, the LAPD began deploying 7,000 body-worn cameras (BWC) to all uniformed patrol officers in the 21 geographic Areas. The LAPD also was rewarded \$710,000 by the Bureau of Justice Assistance (BJA) to further expand the BWC program under the FY 2019 Body Worn Camera Policy and Implementation Program. The LAPD's Tactical Technology Section has worked closely with BJA's BWC training and technical assistance providers and LAPD is a pilot site for its multi-agency study of Digital Evidence Management (DEM). Since the implementation of BWCs, the LAPD has provided local prosecutorial agencies with over 150,000 BWC videos while accumulating more than six petabytes or six million gigabytes of data.

With the continuous increase of footage collected from the BWC and digital in-car video (DICV) systems, the need for a better DEM capability and strategy that can keep pace with this growing amount of data is paramount. While the DEM application currently used is an excellent tool that has served the LAPD well, its capability needs to accommodate the large amount of data and different types of digital evidence such as DICV that is now difficult to share electronically. In addition to improving the capability, what is also urgently needed is a strategy that makes the best use of the application to efficiently facilitate the continued sharing of evidence with our partners from the Los Angeles City Attorney's Office and the Los Angeles County District Attorney's Office while reducing the amount of stored evidence that is no longer required by our retention policy.

In order to address the issues, the project has two goals: 1) establish a comprehensive digital evidence media system that incorporates both BWC and DICV footage for use by law enforcement personnel and prosecutorial agencies; and 2) implement operational procedures and tracking mechanisms that address digital evidence media with regards to retention and deletion. The LAPD aims to store and share all digital evidence in a single repository guided by a comprehensive DEM strategy to ensure that electronic storing and sharing of data will become more efficient and convenient.

The grant award budget includes \$479,275 for civilian and sworn overtime time for establishing and implementing the DEM system. The \$250,000 is allocated for a contractor to centralize and integrate all digital evidence improving the current capability while another \$250,000 is budgeted for a researcher who will evaluate the process. Funding in the amount of \$20,704 is allocated for travel to attend annual conferences and trainings.

The LAPD was not able to include reimbursements for related costs for sworn and civilian overtime in support of this program at the time of application. If the grant is accepted by the City Council and Mayor, the LAPD will submit a budget modification to the grantor requesting to reprogram a portion of the overtime hours to reflect eligible related cost reimbursements for the use of sworn and civilian overtime.

On behalf of Attorney General Merrick B. Garland, it is my pleasure to inform you the Office of Justice Programs (OJP) has approved the application submitted by CITY OF LOS ANGELES for an award under the funding opportunity entitled 2022 BJA FY 22 Body-worn Camera Policy and Implementation Program to Support Law Enforcement Agencies. **Project Description**

With the continuous increase of footage collected from body worn cameras (BWC) and digital in-car video (DICV) systems, the need for a digital evidence management (DEM) strategy that can keep pace with this growing amount of data is paramount. While the DEM application currently used is an excellent tool that has served the Los Angeles Police Department (LAPD) well, what is urgently needed is a strategy that makes the best use of this application to efficiently facilitate the continued sharing of evidence with our partners from the Los Angeles City Attorney's Office and the Los Angeles District Attorney's Office while reducing the amount of stored evidence that is no longer required by our retention policy. This proposal requests funding through Category 3: Digital Evidence Management and Integration Demonstration Projects of the BWC Policy and Implementation Program solicitation (O-BJA-2022-00079-PROD).

The project has two goals:

Goal 1. Establish a comprehensive digital evidence media system that incorporates both BWC and DICV footage for use by law enforcement personnel and prosecutorial agencies.

Goal 2. Implement operational procedures and tracking mechanisms that address digital evidence media with regards to retention and deletion.

The proposal plans to identify methods which increase sharing and case filing efficiency with partner agencies through data migration into a single data repository, plotting annual Department digital evidence data growth to determine how best to minimize storage cost and maximize storage space by implementing reasonable and legal retention limits for digital evidence and deleting evidence no longer needed, identifying active cases (investigations, claims, lawsuits, etc.) involving digital evidence that must be retained beyond standard retention period, and assessing and modifying Department policy for digital evidence management as needed to reflect any changes in current procedures.

The LAPD's Tactical Technology Section has worked closely with Bureau of Justice Assistance's (BJA) BWC training and technical assistance providers (CNA, Arizona State University, and Justice & Security Strategies, Inc.) and LAPD is a pilot site for its multi-agency study of DEM.

The Department will provide BJA with performance measures that include the number of policies and procedures developed, number of videos accessed by Department personnel, number of videos provided to prosecutorial agencies. Quarterly and semi-annual reports, monthly calls, and participation in webinars, conferences, and workshops are part of the deliverables that will be

Among other things, the OJP may withhold award funds, disallow costs, or suspend or terminate the award. DOJ, including OJP, also may take other legal action as appropriate.

Any materially false, fictitious, or fraudulent statement to the federal government related to this award (or concealment or omission of a material fact) may be the subject of criminal prosecution (including under 18 U.S.C. 1001 and/or 1621, and/or 34 U.S.C. 10271-10273), and also may lead to imposition of civil penalties and administrative remedies for false claims or otherwise (including under 31 U.S.C. 3729-3730 and 3801-3812).

Should any provision of a requirement of this award be held to be invalid or unenforceable by its terms, that provision shall first be applied with a limited construction so as to give it the maximum effect permitted by law. Should it be held, instead, that the provision is utterly invalid or -unenforceable, such provision shall be deemed severable from this award.

## 8

Compliance with DOJ regulations pertaining to civil rights and nondiscrimination - 28 C.F.R. Part 38

The recipient, and any subrecipient ("subgrantee") at any tier, must comply with all applicable requirements of 28 C.F.R. ## 11

## 15

Determination of suitability to interact with participating minors

SCOPE. Reg. 51225 (October 1, 2009), DOJ encourages recipients and subrecipients ("subgrantees") to adopt and enforce policies banning employees from text messaging while driving any vehicle during the course of performing work funded by this award, and to establish workplace safety policies and conduct education, awareness, and other outreach to decrease crashes caused by distracted drivers.

## 19

No recipient or subrecipient ("subgrantee") under this award, or entity that receives a procurement contract or subcontract with any funds under this award, may require any employee or contractor to sign an internal confidentiality agreement or statement that prohibits or otherwise restricts, or purports to prohibit or restrict, the reporting (in accordance with law) of waste, fraud, or abuse to an investigative or law enforcement representative of a federal department or agency authorized to receive such information.

The foregoing is not intended, and shall not be understood by the agency making this award, to contravene requirements applicable to Standard Form 312 (which relates to classified information), Form 4414 (which relates to sensitive compartmented information), or any other form issued by a federal department or agency governing the nondisclosure of classified information.

1. In accepting this award, the recipient--

a. represents that it neither requires nor has required internal confidentiality agreements or statements from employees or contractors that currently prohibit or otherwise currently restrict (or purport to prohibit or restrict) employees or contractors from reporting waste, fraud, or abuse as described above; and

The recipient understands that, in accepting this award, the Authorized Representative declares and certifies, among other things, that he or she possesses the requisite legal authority to accept the award on behalf of the recipient entity and, in so doing, accepts (or adopts) all material requirements that relate to conduct throughout the period of performance under this award. The recipient further understands, and agrees, that it will not assign anyone to the role of Authorized Representative during the period of performance under the award without first ensuring that the individual has the requisite legal authority.

### 31

Verification and updating of recipient contact information

The recipient must verify its Grant Award Administrator, Financial Manager, and Authorized Representative contact information in JustGrants, including telephone number and e-mail address. The recipient (and any subrecipient at any tier) must comply with all confidentiality requirements of 34 U.S.C. 10231 and 28 C.F.R. Part 22 that are applicable to collection, use, and revelation of data or information. The recipient further agrees, as a condition of award approval, to submit a Privacy Certificate that is in accord with requirements of 28 C.F.R. Part 22 and, in particular, 28 C.F.R. 22.23.

### 34

Copyright; Data rights

The recipient acknowledges that OJP reserves a royalty-free, non-exclusive, and irrevocable license to reproduce, publish, or otherwise use, and authorize others to use (in whole or in part, including in connection with derivative works), for Federal purposes: (1) any work subject to copyright developed under an award or subaward (at any tier); and (2) any rights of copyright to which a recipient or subrecipient (at any tier) purchases ownership with Federal support.

The recipient acknowledges that OJP has the right to (1) obtain, reproduce, publish, or otherwise use the data first produced under any such award or subaward; and (2) authorize others to receive, reproduce, publish, or otherwise use such data for Federal purposes. "Data" includes data as defined in Federal Acquisition Regulation (FAR) provision 52.227-14 (Rights in Data - General).

It is the responsibility of the recipient (and of each subrecipient (at any tier), if applicable) to ensure that the provisions of this condition are included in any subaward (at any tier) under this award.
