# MOTION

I MOVE that the COMMUNICATION FROM THE LOS ANGELES HOUSING DEPARTMENT relative to approval of the Fiscal Year 2026-27 (FY 26-27) United to House Los Angeles (ULA) Expenditure Plan and related approvals., item No. 31 on today's Council Agenda (CF 23-0038-S7), BE AMENDED to add the following:

AUTHORIZE the General Manager of LAHD, or designee, to disburse up to \$8,881,044 from Fund 66M, appropriation account 43CU03 to the Legal Aid Foundation of Los Angeles to provide eviction defense and homelessness prevention services for the City's Eviction Defense Program and ULA Homelessness Prevention Program.

AUTHORIZE the General Manager of LAHD, or designee, to disburse up to \$1,814,430 from Fund 66M, appropriation account 43CU02 to the Liberty Hill Foundation to provide tenant outreach and education services under the ULA Homelessness Prevention Program.


AUTHORIZE the General Manager of LAHD, or designee, to disburse up to \$552,228 from Fund 66M, appropriation account 43CU04 to SAJE to provide Protection from Tenant Harassment - Tenant Anti-Harassment Ordinance (TAHO) outreach and education tenant services under the ULA Homelessness Prevention Program.

AUTHORIZE the General Manager of LAHD, or designee, to disburse up to \$3,512,181-consisting of \$280,974 from Fund 66M, Appropriation Account 43C00B, and \$3,178,564.62 from Fund 66M, Appropriation Account 43CU19 to the Southern California Housing Rights Center to provide short-term emergency assistance under the ULA Homelessness Prevention Program.

AUTHORIZE the General Manager of LAHD, or designee, to prepare Controller Instructions and make any technical corrections, clarifications, or revisions, including any corrections and changes to fund or account numbers to effectuate the intent of this Motion and authorize the City Controller to implement such corrections. (X) CONSISTENT WITH THE LOS ANGELES CITY CHARTER AND ANY ENACTING LEGISLATION,

INSTRUCT and AUTHORIZE the General Manager of LAHD, or designee, to disencumber all unexpended encumbered funds from Contract No. C-138260 with the Legal Aid Foundation of Los Angeles, and encumber those funds to the new contracts with the Southern California Housing Rights Center, Legal Aid Foundation of Los Angeles, SAJE, and Liberty Hill Foundation for their respective programs under the ULA Homelessness Prevention Program.
