## SOURCE OF ACTIVITY:

On 05/12/23 at approximately 1218 hours, my partner, Officer Marsh #44208 (Passenger), and I, Officer Illsley #44195 (Driver), were assigned Southeast Division, unit 18A35-W2. We were in full L.A.P.D uniform, driving a marked black and white police vehicle, Shop# (81981). We conducted a check of our police vehicle at the start of watch and our emergency lights, forward facing red lights and sirens were in good working order at the time of our inspection. My partner and I were near 400 W. Century (Magic Carpet Inn Motel) conducting extra patrol. The aforementioned location has had an uptick in crime displaying numerous Grand Theft Auto's, Burglary from motor vehicles and Vandalisms. Numerous concerned citizens have requested PD conduct extra patrol due to the recent surge in crimes.

## INVESTIGATION:

My partner Officer Marsh #44208 and I, Officer Illsley #44195 were driving into the Magic Carpet Inn Motel located at 400 W. Century Bl, when we observed a 2011 Red Hyundai Elantra Lic plate [REDACTED] backed into one of the parking stalls. Hyundai Elantra's are one of the most common stolen vehicles due to the lack of security features. Due to the recent surge in crimes deriving from the vicinity of 400 W. Century Bl and the vehicle description, my partner and I proceeded to obtain the license plate. As we traveled eastbound into the parking lot, my partner ran the vehicle for wants and warrants via department resources (MDC) the return came back Code 37 (Stolen).

My partner declared via in car radio we were code 6 on a Code 37 vehicle, requested a backup, airship and a supervisor. While my partner was broadcasting to responding units Suspect 1 was seen exiting the driver's side seat of the stolen vehicle. He quickly hunched his shoulders forward, turned his back to PD and began to move his baseball hat lower to shield his face from PD. Without hesitation Suspect 1 attempted to distance himself from the stolen vehicle. Suspect 2 was seen exiting the front right passenger seat of the stolen vehicle. Suspect 2 quickly closed the door behind her and began to walk towards the rear of the vehicle. My partner and I observed an additional passenger in the back seat of the vehicle later identified as ([REDACTED] DOB: [REDACTED]).

Due to Suspect 1 and Suspect 2 outside of the vehicle, the positioning of our marked black and white police vehicle and the layout of the parking lot I gave precise verbal commands to face the wall of the building and comply with PDs commands. We voiced to the rear passenger to stay inside the vehicle until further. As my partner continued to broadcast, I maintained communication with the suspects to maintain their position. As units arrived on scene, the rear passenger was ordered out of the vehicle. Both suspects and rear passenger were taken into custody without incident. The vehicle was cleared for additional bodies.

Both suspects and the rear passenger were taken back to Southeast Station pending a GTA investigation. The rear passenger was ran for wants and warrants while at Southeast Station and was released after negative results.

## Arrest:

Suspect 1 was arrested for 10851 (A) V.C Driving Without Owners Consent. Suspect 1 was transported to Southeast Station for booking.

Suspect 2 was arrested for 10851 (A) V.C Driving Without Owners Consent. The suspect also 11377 (A) H&S \$5,000 warrant. Suspect 1 was transported to Southeast Station for booking.

Officer Villa #45100 admonished Suspect #1 in Spanish utilizing the LAPD's Field Officers Notebook and the following was stated.

You have the right to remain silent. Do you understand? Yes.

Anything you say may be used against you in court do you understand? Yes.

You have the right to the presence of as attorney before and during any questioning. Do you understand? Yes.

If you cannot afford an attorney, one will be appointed for you, free of charge, before any question, if you want. Do you understand? Yes.

Suspect 1 stated he was not aware the vehicle was stolen and that he was simply sitting in the driver seat. He stated he knew the vehicle was on due to the air conditioner being operable but never noticed a key in the ignition. He stated he was sitting in the vehicle for approximately 20 minutes prior to PD interaction. Suspect 1 stated he observed a male Hispanic who goes by, "Sinaloa" in the driver's seat for approximately 15 minutes prior to him sitting in the driver's seat.

While admonishing Suspect 1, Suspect 2 made spontaneous statements. She ascertained what Suspect 1 was being charged with, as I informed her, she stated she was the driver of the stolen vehicle. She stated Suspect 1 was simply sitting in the driver seat for the air conditioning after she drove the vehicle there.

I proceeded to admonish Suspect #2 utilizing the LAPD's Field Officers Notebook and the following was stated.

You have the right to remain silent. Do you understand? Yes.

Anything you say may be used against you in court do you understand? Yes.

You have the right to the presence of as attorney before and during any questioning. Do you understand? Yes.

If you cannot afford an attorney, one will be appointed for you, free of charge, before any question, if you want. Do you understand? Yes.

Suspect 2 stated she was unsure where she picked up the stolen vehicle from but stated in was on 05/12/23 sometime in the morning. She proceeded to tell me she drove the stolen vehicle for approximately 15-20 minutes prior to going to 400 W. Century. She stated she was never handed vehicle

## **ADDITIONAL:**

400 W. Century has been a problem location for officers in recent times. Officers have had numerous radios calls at the location with numerous GTA's, BFMV's and Vandalisms. A common tactic used by carjacking thief's and car strippers is to utilize parking lots and major streets with an abundance of vehicles to deflect the attention from the act they're carrying out.

My partner reached out to the RO and was able to make contact via cellphone with the RO's fiancé. The RO's fiancé stated they gave no one permission to drive the vehicle. She stated she did not know the suspect and she was in possession of all vehicle keys. They did not give anyone permission to drive the vehicle.

Based on my partner and I observing Suspect 1 inside the driver seat of the stolen vehicle while the engine was running and Suspect 2 making statements it was her that drove the vehicle to the motel, both suspects were arrested for **10851 (A) V.C Driving Without Owners Consent**.
