Comments for Public Posting: City Council: I urge you to vote NO on Council File 23-0479 from CM Traci Park. The Ellis Act is not intended (and explicitly disallows) eviction for the sake of renovation to bring units that were previously rent-controlled up to market rates. Douglas Emmett is exploiting the lax regulation of the Ellis Act to profit by evicting tenants. City Council must condemn Douglas Emmett's action and the City Attorney should disallow this illegal activity. This illegal eviction process will displace hundreds of tenants and increase the cost of housing in LA. This increase will directly contribute to the number of people forced to live on the street due to unaffordable rent. As if in preparation for the public reaction to this predatory biz plan, in Oct 2022 Douglas Emmett contributed \$400k to the victorious election campaign of Traci Park, who is now urging tenants to apply for relocation assistance from the LA Housing Department. This is convenience and dare I say, corruption by lobbyists at its finest. Douglas Emmett is trying to set a dangerous precedent which other high -rise landlords will exploit, using the Ellis Act to evict tenants in order to bring prices up to market rate. None of this has to happen. In November 2022, the people of LA voted to approve and fund new programs at the LAHD to protect the kind of rent-controlled housing found at Barrington Plaza and prevent evictions like those Douglas Emmett is attempting. These programs were authorized under ULA which will raise as much as \$600m for the LAHD, \$62m of which is explicitly for this year's acquisition and rehabilitation of old apartment buildings. The city should acquire Barrington Plaza, renovate the building while minimizing long-term displacement, and ensure the housing remains affordable for people into the future.
