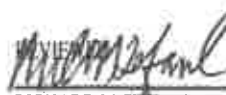

DISCUSSION

This donation will provide laser engraving equipment for the Metropolitan Division's Armory Section. Currently, Metropolitan Division tracks its firearms using a barcoded sticker affixed to the weapon. These stickers are prone to becoming peeled away, damaged, and/or unreadable due to normal use and storage, cleaning, and maintenance. The equipment will be used to permanently engrave a designated Department barcode to firearms. Approval of this grant will provide the proper identification of highly sensitive equipment (firearms) and reduce tracking and inventory errors.

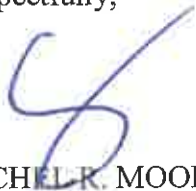

NAME OF REQUEST: METROPOLITAN DIVISION LASER ENGRAVING EQUIPMENT

It is requested that Metropolitan Division be approved for funding for the purchase of a laser engraving/marketing system.

The system will be housed at the Los Angeles Police Department's (LAPD) Metropolitan Division Armory and will be specifically designated for use by Metropolitan Division Armory personnel only. The cost of the laser engraving/marketing equipment is ~~\$26,117.53~~ and will be purchased through LaserStar Technologies based out of Orlando, Florida. ~~\$26,117.53~~ \$26,827.03

Metropolitan Division has over 3,500 firearms (rifles, shotguns, pistols, launchers, etc.) in inventory. These weapons require tracking with the Department's Kitroom Inventory Tracking System (KITS) whenever they are issued to individual officers, in for repair or during Armory Audits. The KITS system uses an adhesive based barcode sticker for scanning and tracking. The stickers are prone to being peeled away, damaged, and/or unreadable due to normal use and storage or cleaning/maintenance. The damaged/unreadable barcodes cause possible problems with the tracking and inventory of highly sensitive equipment (firearms).

The "LaserStar" laser marking system is capable of permanently engraving a designated LAPD barcode to the firearms. This procedure will provide the proper and permanent identification of firearms which integrates with the current KITS system to uphold accountability, reduce tracking/inventory errors and the constant need to re-apply the current barcode stickers.

In addition to firearms, this system can also be used to permanently barcode other high value and sensitive equipment assigned to Metropolitan Division, Special Weapons and Tactics (SWAT) and K9.

Over time this marking system will reduce errors and the time officers spend on re-applying and updating damaged or unreadable barcodes. There will be no need to purchase sticker barcodes in the future.
