On October 10, 2023, the Public Safety Committee considered a September 27, 2023 Los Angeles Police Department (LAPD) report relative to the release of remaining Interim Homeless Housing Funds. After consideration and having provided an opportunity for public comment, the Committee moved to make the following recommendations:

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. TRANSFER appropriations in the amount of \$6.27 million from the Unappropriated Balance Fund No. 100/58, Police Department Sworn Overtime, Interim Homeless Housing, to the LAPD, Fund No. 100/70, Account No. 1092, Sworn Overtime.
2. AUTHORIZE the LAPD to make technical corrections as necessary, subject to the approval of the City Administrative Officer (CAO).
3. INSTRUCT the LAPD to report quarterly, beginning at the November 28, 2023 Public Safety Committee meeting, in regard to how the funding described above in Recommendation No. 1 has been allocated.

Additionally, during the meeting, Councilmember Soto-Martinez proposed the following alternative recommendation:

TRANSFER appropriations in the amount of \$6.27 million from the Unappropriated Balance Fund No. 100/58, Police Department Sworn Overtime, Interim Homeless Housing, to new accounts for each Council Office, in the amounts designated per Council District included in the July 27, 2023 LAPD report, attached to the Council File, for expenditure by each Council Office for the support of interim homeless housing sites, with the proviso that any such amounts not spent, allocated, encumbered, or declared to the City Clerk for retention in the new account by any Council Office at the end of three

months shall be transferred to Fund No. 100/70, Account No. 1092 (Sworn Overtime). After the vote was taken, as detailed below, the Committee moved to recommend the first set of recommendations as detailed above. This file is now transmitted to the Budget, Finance, and Innovation Committee.
