## **SUBJECT : PROPOSED SOLID RESOURCE RATE ADJUSTMENT**

Honorable Members:

In accordance with Proposition 218, the City of Los Angeles Department of Public Works, Bureau of Sanitation (LASAN) provided written notice by mail to all affected property owners and customers of a proposed increase to LASAN's Solid Waste Collection, Transfer, Recycling, Recovery of Waste Resources and Disposal Fee (Solid Resources Fee). Included in that notice was the amount of the proposed rates to be imposed, the basis upon which the amount of the proposed rates was calculated, the reason for the proposed rates, and the date, time, and location of the public hearing regarding the proposed rates. Consistent with the requirements of Proposition 218, the notice also included information of the process through which to submit written protests against the proposed rates. The Office of the City Clerk (City Clerk) has tabulated the valid written protests that were submitted to the City Clerk by the public hearing date of September 30, 2025.

LASAN identified 741,242 parcels upon which the rates are proposed for imposition. For there to be a majority protest, valid written protests associated with 370,622 parcels, which constitute a majority of affected parcels, must have been received by September 30, 2025. This majority protest threshold was not met because valid written protests against the proposed Solid Resources Fee rates have not been received from a majority of affected parcels. The Council may proceed with the adoption of an ordinance associated with these rate adjustments. The certified results of the tabulation of valid written protests are attached. I have also forwarded a copy of these results to LASAN, for their information.
