

ORDINANCE NO. _____

An ordinance amending Section 12.04 of Chapter I, and Section 1.5.2 of Chapter 1A, of the Los Angeles Municipal Code (LAMC) and Ordinance No. 184,246, to remove the Boyle Heights Community Plan Area from the Clean Up Green Up Supplemental Use District and amend the zoning map accordingly.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The City Zoning Map, pursuant to LAMC Section 12.04 and LAMC Chapter 1A, Sec. 1.5.2, shall be amended to show the boundaries of the Clean Up Green Up (CUGU) Supplemental Use District, established in Ordinance No. 184,246, as shown in the attached maps (Map Sheets 1-3) in the shaded areas inside the dashed lines identified in the legend as "CUGU Supplemental Use District."

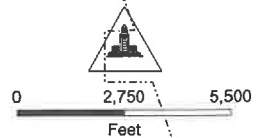

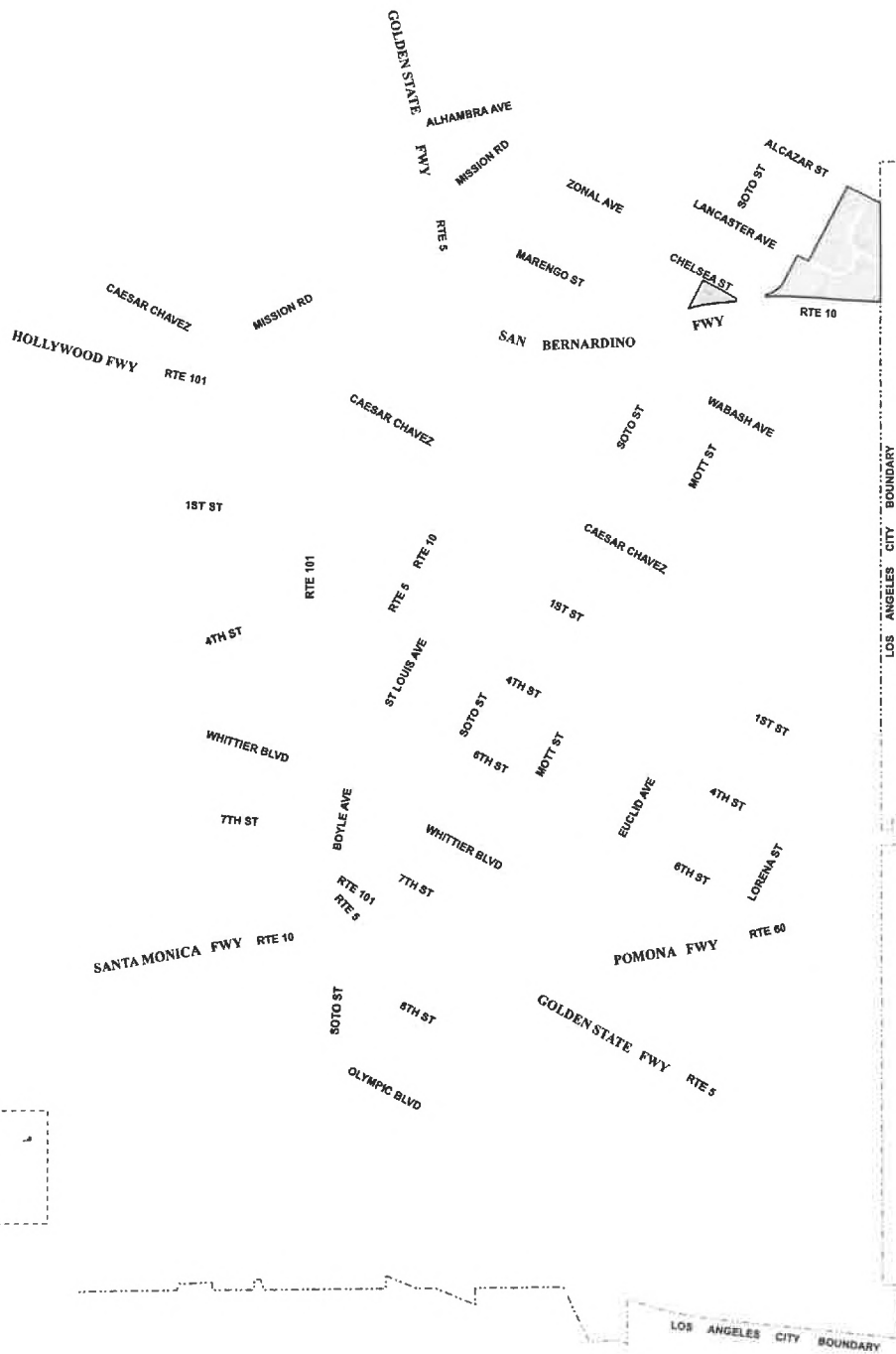

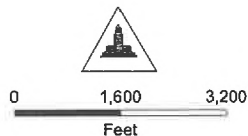

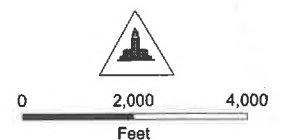


 Amended Clean Up Green Up District Boundary
