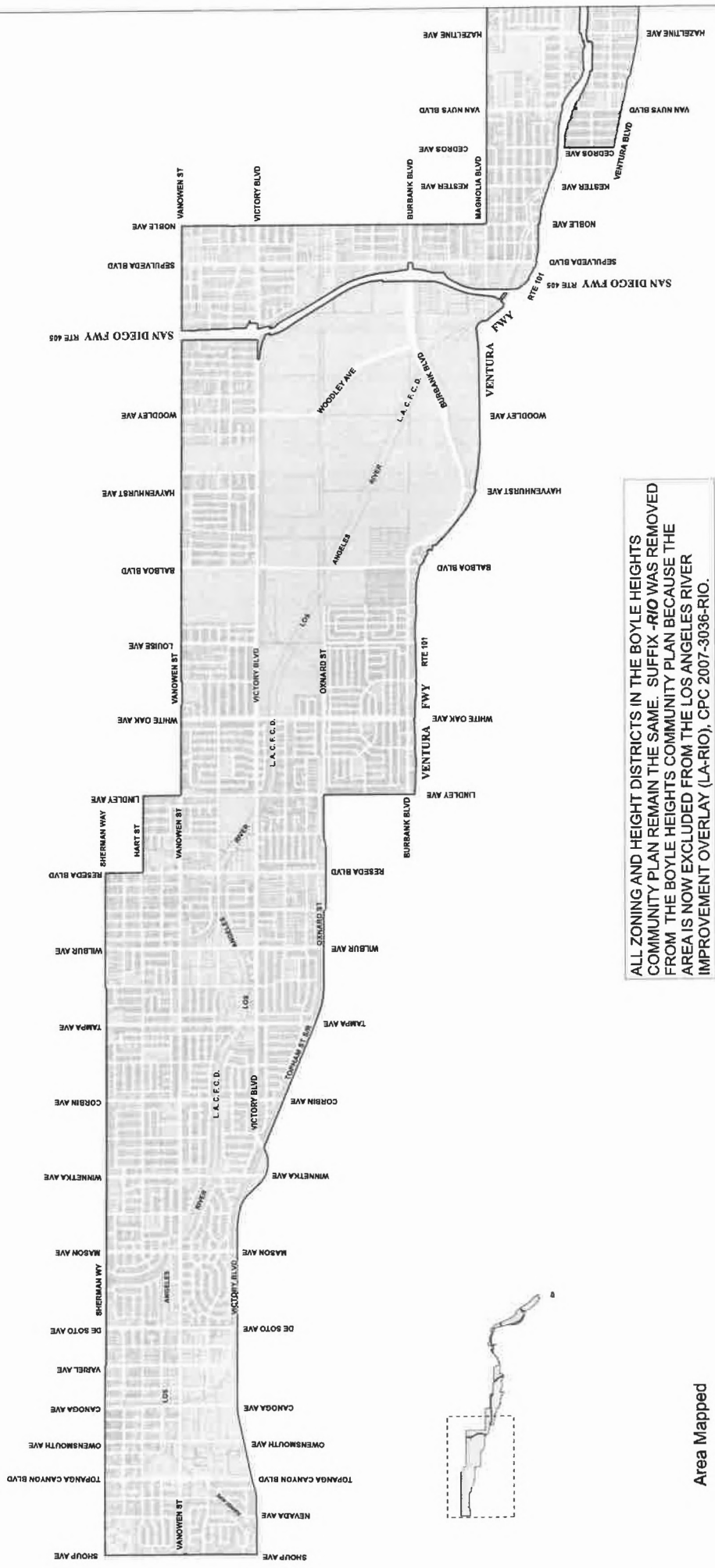


ORDINANCE NO. 189002

An ordinance amending Section 12.04 of the Los Angeles Municipal Code (LAMC) and Section 1.5.2 of Chapter 1A of the LAMC and Ordinance No. 183,144 (as amended by Ordinance No. 188,422), to remove the Boyle Heights Community Plan Area from the Los Angeles River Improvement Overlay District and amend the zoning map accordingly.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The City Zoning Map, pursuant to LAMC Section 12.04 and LAMC Chapter 1A Section 1.5.2, shall be amended to show that the boundaries of the River Implementation Overlay (RIO) District, established in Ordinance No. 183,144 and amended in Ordinance No. 188,422, are as shown in the attached maps (4 plan sheets) in the shaded areas inside the solid line identified in the legend as "Amended Los Angeles River Improvement Overlay District Boundary":

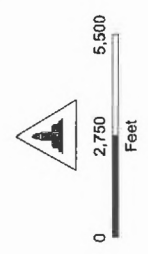

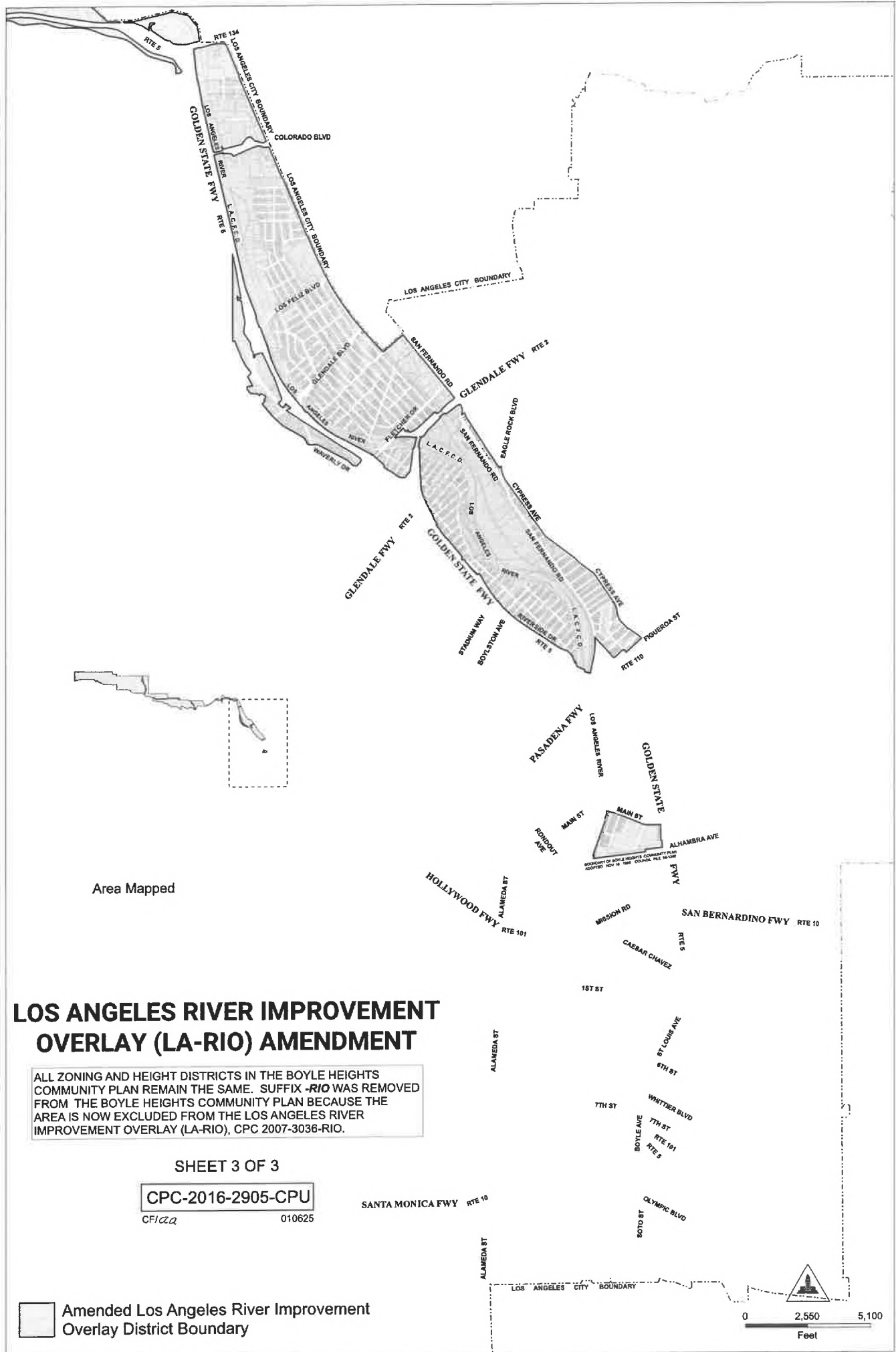
 Amended Los Angeles River Improvement Overlay District Boundary

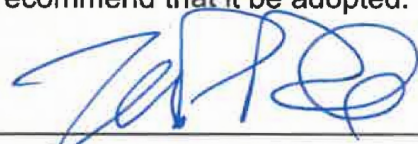
