The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

To the Los Angeles City Council:

The Watts Neighborhood Council respectfully submits this Community Impact Statement in support of Council File 23-0882 and the establishment of Community Advisory Boards associated with interim housing solutions.

The Watts community understands the urgency of addressing homelessness. We recognize that every person deserves access to shelter, supportive services, and pathways toward stable housing. We also recognize that successful housing solutions require meaningful collaboration with the communities in which these projects are located.

Too often, residents feel disconnected from decisions that directly affect neighborhood conditions, public services, infrastructure, and quality of life. Community Advisory Boards can help bridge that gap by creating formal opportunities for communication, transparency, accountability, and problem-solving.

The Watts Neighborhood Council strongly believes that communities should be treated as partners rather than afterthoughts in the planning and operation of interim housing facilities.

Addressing homelessness requires compassion, accountability, and partnership. Community Advisory Boards offer a pathway to strengthen trust while improving outcomes for both residents and individuals seeking housing assistance.

For these reasons, the Watts Neighborhood Council supports Council File 23-0882 and encourages the City to adopt a community-centered approach that promotes transparency, collaboration, and shared responsibility.
