Comments for Public Posting: In the past few years, the number of people forced to live in their vehicles has exploded, creating an untenable situation for both the unhoused and those who live near many collections of RVs occupying our public streets. These RV encampments take up public parking spaces and create unsafe and unsanitary environments for both those living in the vehicles and those who live nearby. Over the past few years, I have personally witnessed two large wildfires in the Ballona Wetlands that have threatened nearby neighborhoods and irreparably damaged this important ecological reserve. Even prior to the fires, it was disheartening to see the destruction and unsafe conditions created in the Wetlands due to the large encampment, which prohibited the public from experiencing and enjoying its natural beauty. Additionally, our community has experienced an uptick in property crimes and I have personally witnessed unhoused persons breaking into our parking garages and stealing bicycles and other personal property. There had also been numerous instances of violent crime at these RV encampments, including shootings. I implore the City to designate streets outside of Playa Vista where oversize vehicle dwellings can safely park with access to services, including sanitation, restroom facilities, and a pathway to permanent housing. It is inhumane to allow the unhoused to live in these unsafe and unsanitary conditions. It is clear that nothing that the City has done so far has worked to address this issue and while the temporary encampment clean-ups are appreciated, it is clear that a permanent and sustainable solution is needed. Without this ordinance, the city has no power to move these RVs and the local neighborhood including our children, our friends and our family suffer as a result.
