Comments for Public Posting: Dear Members of the Los Angeles City Council: I submit comments to you today to respectfully ask that you follow through on the recommendations of the Cultural Heritage Commission and approve designation of the property at 12305 Fifth Helena Drive in Brentwood, also known as the Marilyn Monroe Residence. As a Los Angeles resident and the leader of the Where Women Made History initiative of the National Trust for Historic Preservation--the country's only national preservation advocacy organization--I am keenly aware that women's history and achievements have been systematically excluded from the places that we officially recognize as important to our shared heritage. Of the 1,300 Historic Cultural Monuments designated in Los Angeles over the last 65 years, less than 3% of them are designated because of their connections to women. Women's history is quite literally everywhere, and In a City and County that today are led by women in positions of political power, this staggeringly low percentage of representation is an egregious and very public example of gender inequity. It clearly communicates the intentional erasure of the many ways that women of all identities have influenced the history, culture, politics, and economics of Los Angeles. The National Trust and the Los Angeles Conservancy are currently piloting a multi-year project called Los Angeles Women's Landmarks, specifically to address this gender bias by amending existing Historic Cultural Monument nominations to include the overlooked women's history, to designate new HCMs for their connections to the life and work of Los Angeles' women and women of color, and to create a new national model for increasing gender equity in the designation process and communicating the impact of women on this City to the public. You have an opportunity today to help correct this long-standing oversight by recognizing the importance and agency of Marilyn Monroe in the history of this property. Her involvement has been clearly articulated in the research presented in the Historic Cultural Monument nomination before you for approval. The current property owners may disagree with this assessment because it conflicts with their plans to demolish the property and erase this chapter of Ms. Monroe's personal history, and they happen to have the means to take legal action. I hope that you will not choose to set a dangerous

precedent by allowing only those owners with financial means to determine which aspects of our collective history are worth recognizing and protecting. It is past time that we respect and value the contributions women have made to the history of Los Angeles and the places where they helped shape that history.
