Statement of Community Impact re Moratorium on Breeding Permits

Re: Motion #23-1008

Since 1968, the Glassell Park Improvement Association has worked to fulfill our mission of maintaining and improving quality of life issues in our community. When our founders spoke of "quality of life", they weren't just talking about humans!

We **strongly support** our Councilmember Eunisses Hernandez's motion to place a moratorium on issuing breeding permits in Los Angeles.

The GPIA is working with CM Hernandez's office to bring a dog park to Glassell Park, and we have participated with other local organizations to bring pet adoption events as well as mobile spay/neuter clinics to the community.

We are very aware of the overcrowding in our local shelters, the overburdening of shelter staff and the unfortunate minimizing of care for the animals held there.

We believe there should not only be a moratorium on all breeding permits; but that the breeding permits program be reevaluated to, perhaps, lower the number of permits issued annually, and limit permits to only breeders of working dogs and those who actively campaign their dogs in sport or confirmation.
