REPORT

SUMMARY

On September 9, 2020, the City Council approved funding for the initial projects under the COVID-19 Homelessness Roadmap (Roadmap) and directed this office to submit future funding recommendations through reports, and under the June 14, 2022, Alliance Lawsuit Settlement Agreement, the City of Los Angeles is required to develop 12,915 new interim or permanent housing units or other interventions by June 13, 2027, to accommodate 60 percent of unsheltered persons experiencing homelessness within the City as listed within the 2022 Point-In-Time Count. This report provides funding recommendations that bring the City to compliance for these agreements.

This report provides exemption determinations from the California Environmental Quality Act for a number of sites that are undergoing service provider transitions and lease extensions. Furthermore, this report includes funding recommendations for the continuation of various homelessness services through Fiscal Year 2025-26 using multiple funding sources such as Homeless Housing, Assistance, and Prevention funds, Measure A Local Solutions Fund, General Fund, and County Roadmap funds. All other recommendations that are necessary to effectuate these changes, such as contract and expenditure authorities, are also included.

The recommendations in this report utilize the Homeless Housing, Assistance, and Prevention funding and anticipated reimbursements from the County for the Measure A Local Solutions Fund for homelessness services and interventions. This funding supplements the City's General Fund amounts budgeted and approved in the 2025-26 Adopted Budget for Alliance Settlement and Citywide Homeless Interventions, inclusive of anticipated reimbursements from the County for eligible service costs for the Alliance Settlement.

RECOMMENDATION

That the City Council, subject to approval by the Mayor:

Imperial Highway, the Bridge Housing/low barrier navigation center at 310 N. BACKGROUND

LA Alliance Lawsuit

On March 10, 2020, the LA Alliance for Human Rights, a coalition of downtown Los Angeles residents and business owners, including persons who are currently experiencing and have formerly experienced homelessness, filed suit against the City and the County of Los Angeles ("County") for violating various State and federal laws in connection with the City's and County's alleged failures in responding to homelessness.

Homelessness Roadmap Agreement

On May 15, 2020, the U.S. District Court of Central District of California (District Court) issued a preliminary injunction requiring the City and the County to relocate and shelter all homeless individuals living near freeway overpasses, underpasses, and ramps. On June 16, 2020, the City reached an agreement to create 6,700 new homeless housing units within 18 months to address the COVID-19 emergency. This agreement is referred to as the Homelessness Roadmap.

The City is required to open and maintain 6,000 new beds, not covered by existing City-County agreements. The County has provided up to \$60 million in annual service funding, totaling up to \$300 million over the five-year agreement term, based on the number of interventions open and occupied within 60 days of July 1st each year. The agreement will terminate on June 30, 2025; therefore, Fiscal Year 2024-25 marks the fifth and final year of the Homelessness Roadmap.

The City has met all obligations under the agreement and will continue to do so. As of March 31, 2025, 7,624 new beds are open and occupiable, which includes 2,679 rapid rehousing/shared housing point-in-time placements overseen by the Los Angeles Homeless Services Authority (LAHSA)¹.

¹ On June 11, 2025, the City updated the number to 2,667 from 2,679 Rapid Rehousing which reduced the total number of open and occupiable beds reported for the guarter ending March 31, 2025, to 7,482.

Alliance Settlement Agreement

On June 14, 2022, the District Court approved a Settlement Agreement (Settlement) between the City and the plaintiffs and dismissed the City from the lawsuit. Under the Settlement, the City is required to develop 12,915 new interim or permanent housing units or other interventions by June 13, 2027, in order to accommodate 60 percent of unsheltered persons experiencing homelessness (PEH) within the City based on LAHSA's 2022 Point-in-Time Count who do not have a serious mental illness. As of March 31, 2025, there are 6,724 new interventions open and occupiable and 4,278 interventions in progress, for a total of 11,002 units or beds that satisfy the intent of the Settlement. The recommendations in this report provide funding for open sites as well as in progress interim housing sites currently in the pipeline.

On May 2, 2024, the City and County of Los Angeles executed a Memorandum of Understanding, under which the County has allocated up to \$259 million for services for the City's interim housing requirements under the Settlement. The City is responsible for initially funding the beds and invoicing the County in arrears for the cost of services. The County will reimburse at the bed rates established by the City and the Los Angeles Homeless Services Authority (LAHSA), which were approved by the City Council on December 3, 2024. The County will contract for and directly fund permanent supportive housing (PSH) services for PSH units established by the City. The MOU will terminate on June 30, 2027.

DISCUSSION

Alliance Settlement Agreement Program

The total recommended budget for the services at three currently operating interim housing sites counting toward the Settlement obligation for FY 2025-26 outside of the Inside Safe Program is \$7.7 million. The three interim housing sites are Highland Gardens Hotel in Council District 4, 4969 Sunset Boulevard in Council District 13, and the Tiny Home Village at 2377 Midvale Avenue in Council District 5. As part of the executed Memorandum of Understanding (MOU), the County is to reimburse the City for services rendered at the Alliance interim housing sites. As such, the City is required to front-fund services and request reimbursements from the County. A total of \$39 million is anticipated to be reimbursed from the County for FY 2024-25 service costs. The reimbursement will be used to continue support for the three interim housing sites listed above and for the service costs for Inside Safe sites that are counting toward the Settlement, including the Mayfair interim housing site in Council District 1 and hotel/motel occupancy and booking agreements.

This report also recommends renewing the approval of funding for 2024-25 services at Highland Gardens Hotel and 4969 Sunset Boulevard. Funding was previously approved

in the First Funding Report - Alliance Settlement Agreement Program (C.F. 23-1022-S3) and partial funding was transferred at the beginning of the fiscal year. Due to delays in the reimbursement process, the remaining funding will not be transferred by June 30, 2025, and renewal of approval is requested in this report.

Additionally, a funding transfer and contract authority are included to support rental subsidies and operating expenses for Master Leasing sites through LAHSA's Master Leasing Strategy. Currently, there are 10 Master Leasing sites (462 units) counting toward the Settlement obligations. Also included is the extension of the expenditure authority for HHAP-3 funds previously approved for construction costs for the Project Homekey 1.0, Travelodge Normandie site in CD 15 (40 units), which is an in-progress site in the Settlement pipeline. The report also recommends funding for services at a site with 15 beds located at 10864 Rochester Ave. in CD 5 serving Transitional Aged Youth (TAY), which may be an Alliance-eligible site and is discussed further in the subsequent section entitled, Homeless Housing, Assistance, and Prevention Rounds 2, 3, and 4. This report also recommends reserving \$1,000,000 for a contract to monitor the Alliance Settlement progress.

Lastly, funding in the amount of \$16.3 million is recommended in this report for 672 Time-Limited Subsidies, which is further discussed in the section entitled, HHAP-5 Funding Category 3: Rapid Rehousing and Housing Navigation.

Measure A Local Solutions Fund

Measure A, officially titled the Affordable Housing, Homelessness Solutions, and Prevention Now Transactions and Use Tax Ordinance, was adopted by voters in November 2024. This initiative repeals the previous Measure H and replaces its 0.25 percent sales tax with a higher 0.5 percent sales tax to be collected countywide, generating an estimated \$1 billion annually starting April 2025. Sixty percent of the funds will go directly to Los Angeles County to support Comprehensive Homelessness Services, which encompass prevention strategies, emergency and permanent housing, healthcare access, and employment support. Within this allocation, 15 percent is earmarked for the Local Solutions Fund (LSF), which will be distributed to individual cities, including the City of Los Angeles, and councils of governments to implement community-level housing and homelessness initiatives. An additional 1.65 percent of the County's share is dedicated to Homelessness Solutions Innovations, enabling the development and testing of new strategies that could be scaled countywide.

The City of Los Angeles is expected to receive \$54,929,640 of the LSF portion based on its large population size and the high concentration of homelessness. The distribution formula is based on HUD's Point-in-Time Count and other metrics of housing instability. These funds can be used for local interventions such as expanding interim housing, outreach, and affordable housing projects. The funding is on a

reimbursement basis and this report recommends using LSF to support ongoing non-Alliance interim housing obligations, such as Tiny Home Village (\$43,261,260) and Project HomeKey 1.0 (\$11,668,380) operations for a total cost of \$54,929,640. In order to have sufficient cash to front fund a quarter of services (\$13,732,410) until the City can be reimbursed, HHAP accrued interest (\$10,970,297) and a portion of the General City Purposes (GCP) - Citywide Homeless Interventions funding (\$2,762,113) will need to be used. It is critical to allow these eligible funding sources to be used or else the City will be unable to support LSF eligible costs and therefore be unable to receive reimbursement from the County.

Beyond the County's allocation, 35.75 percent of the tax revenue will be directed to the Los Angeles County Affordable Housing Solutions Agency (LACAHSA). These funds will be used to construct, preserve, and plan affordable housing, as well as to fund tenant protection measures and rental assistance programs. Another 3 percent will go to the Los Angeles County Development Authority (LACDA) to support local housing production efforts, ensuring new housing units are brought online in areas of need. Finally, 1.25 percent of the funds will be dedicated to Accountability, Data, and Research, to ensure rigorous oversight, performance tracking, and transparency in the use of Measure A resources. Any funding recommendations for this portion of Measure A will be included in a future report.

Service Provider Transitions

On December 6, 2024, LAHSA released a Request for Proposals (RFP) for the single adult interim housing portfolios of the City and County of Los Angeles. For City sites, proposers were required to submit budgets that utilized the newly approved single adult interim housing bed rates of \$116 and \$89. The results of this RFP have led to the transitioning of new service providers for the following sites beginning July 1, 2025:

The recommendations in this report would provide the General Services Department, Real Estate Services Division the authority to enter into the necessary agreements with the new service providers to operate the existing sites. To further support the transitions of these sites, the Bureau of Engineering (BOE) has conducted California Environmental Quality Act (CEQA) analyses for these sites, which are transmitted under a separate cover. The Mayor and City Council must approve BOE's determinations that these uses are categorically exempt from CEQA in order to proceed.

The current service provider of the Westlake Tiny Home Village, Urban Alchemy, will remain on site through July 31, 2025 to ensure that a warm handoff will occur with the new service provider, Hope the Mission. This will require a contract extension at no cost to the City, as LAHSA has identified unspent funds to be utilized to support this process. Furthermore, this report reprograms a total of \$586,960 of unspent FY 2024-25 County funds, as identified by LAHSA, from transferring sites. Upon approval, these funds will be reallocated to support the ramp down efforts of two sites that are slated to close on September 30, 2025, which include Isaiah's House in CD 13, located at 5941 Hollywood Blvd., and a New Reflections site in CD 8 located at 608 W. 95th Street (Formerly 8501 1/2 S. Vermont Ave.).

Homelessness Interventions Lease Extensions

This report recommends extending the agreements of two interim housing sites that count towards the Roadmap agreement for up to one year. The properties for the proposed extensions are used for interim housing rent-free, thus there are no leasing costs associated with extending the agreements.

The General Services Department (GSD) holds agreements with the Department of Recreation and Parks (RAP) for Right-of-Entry at the two sites. Approval of this report would authorize GSD to execute new, or amend existing, agreements with RAP and lease agreements with the site's respective service providers for one additional year. Table 2 provides further detail of the sites and the new lease term.

Furthermore, this report recommends extending the lease for the ReFresh Spot located at 544 Towne Avenue in Council District 14 for up to two years. On April 7, 2025, the Mayor and Council approved up to \$319,907.34 of Additional Homeless Services - CD 14 funds to support the lease costs of the ReFresh Spot located from April 2025 through June 2026 (C.F. 19-0644).

The Bureau of Engineering (BOE) has conducted California Environmental Quality Act (CEQA) analyses for these sites, in which the Notice of Exemptions are transmitted under a separate cover. The Mayor and City Council must approve BOE's determinations that these uses are categorically exempt from CEQA in order to proceed.

Homeless Housing, Assistance, and Prevention Round 5

The State of California's Homeless Housing, Assistance, and Prevention Round 5 (HHAP-5) Program, administered by the California Interagency Council on Homelessness (Cal-ICH), provides local jurisdictions funding to support regional coordination and expand or develop local capacity to address immediate homelessness challenges. The City was awarded a total allocation of \$164.3 million under HHAP-5, and all funds must be expended by June 30, 2028.

On March 22, 2024, the City Council and Mayor approved the expenditure framework (C.F. 20-1524-S7, CAO Report dated March 15, 2024) as shown in Table 3 below.

HHAP-5 Funding Category 1: Interim Housing

Funding under HHAP-5 Funding Category 1: Interim Housing is recommended for the continuation of services for existing interim housing interventions and program delivery. The current budget for this funding category is \$98.2 million. A transfer in the amount of \$2.8 million is recommended to be programmed from HHAP-5 Funding Category 6: Administrative Costs and Systems Support to support the continuation of the services at the City's existing interim housing interventions. The new recommended budget for HHAP-5 Funding Category 1: Interim Housing will be \$101 million.

Interim Housing Operating Costs

Funding is recommended to continue operations at 49 interim housing interventions in Fiscal Year 2025-26. The estimated total cost to continue the operations of existing interventions with HHAP-5 funds is \$96.9 million. The recommendations in this report continue funding of services for 43 interventions and leasing for 11 sites. The operations of the interim housing interventions are managed by LAHSA. Funding is also recommended to continue to support 16.87 Full-Time Equivalent (FTE) staff at LAHSA, who support the operations oversight of the City's interim shelter interventions. Additionally, this report recommends level funding in the amount of \$2.4 million to support the Inclement Weather Program, which can support approximately 264 beds and vouchers during adverse weather conditions. The actual number of beds supported will depend on the configuration of beds and vouchers used.

HHAP-5 Funding Category 2: Housing Operations in Skid Row

Funding is recommended under the Housing Operations in Skid Row category to support various interventions and supportive services within the Skid Row area. The currently approved budget for HHAP-5 Funding Category 2: Housing Operations in Skid Row is \$2 million. A transfer of \$9.3 million of unobligated funding in HHAP-5 Funding Category 4: Outreach, Hygiene, Prevention, and Supportive Services is recommended to be allocated to the HHAP-5 Funding Category 2: Housing Operations in Skid Row to continue funding for existing services in Skid Row for a total budget of \$11.3 million.

Shelter Interventions

Funding in the amount of \$1,423,110 is recommended to be allocated to LAHSA for the Downtown Women's Center Rapid Rehousing program. Funding will provide rental subsidies to women experiencing homelessness in Council District 14. Funds will have the ability to provide rental assistance to 100 households.

Hygiene Services

Funding in the amount of \$4.9 million is recommended to be allocated to the Board of Public Works to continue services for the Mobile Pit Stop, the Mobile Shower, and Sidewalk Litter Abatement programs in Skid Row. This reflects a decrease of \$0.49 million from Fiscal Year 2024-25; however, the 2025-26 budget is based on the expected need as determined by the Board of Public Works. The Pit Stop program provides mobile hygiene services for 12 hours per day and seven days a week. Secondly, the Mobile Shower Program operates two mobile shower trailers with each trailer being deployed to one location per day for five days a week. Thirdly, the Sidewalk Litter Abatement program will provide cleaning services, which includes, sidewalk sweeping, sanitation of public fixtures, debris removal, collection of litter, including sharp objects removal, and collection and reporting of large items from the right-of-ways and public spaces. HHAP-5 funding is also recommended for the Bureau of Sanitation to continue the Sharp Collection Box program, which places six sharp collection boxes that are co-located at four Pit Stop locations, The Bin, and the ReFresh Spot in Skid Row.

This report recommends providing funding in the amount of \$2.03 million to LAHSA for the continuation of various hygiene services such as the People Concern and Los Angeles Mission Hygiene Program and the ReFresh Spot Program. The People Concern and Los Angeles Mission Shower Programs provide public restrooms and shower facilities 24-hours a day for people experiencing homelessness in the Skid Row. The restroom includes both shower and toilet services. Thirdly, funding is recommended for the continued expanded services of the ReFresh Program and Community Ambassadors to provide 24-hour seven days a week access to restrooms, service engagement, and security to people experiencing homelessness.

Outreach

Funding is recommended to continue the Skid Row Homeless Engagement Teams (HETs), which are two two-person teams assigned to the Skid Row area for street engagement. Skid Row HETs are deployed within the Skid Row area that include at least one bilingual HET staff member. These additional teams are meant to expand the existing capacity of outreach in parallel to other outreach efforts within the area.

Other Supportive Services

This report also recommends the continuation of Climate Centers, which will provide temporary stations for individuals in the Skid Row area during inclement weather.

HHAP-5 Funding Category 3: Rapid Rehousing and Housing Navigation

The current budget for HHAP-5 Funding Category 3: Rapid Rehousing and Housing Navigation is \$11.9 million. A transfer of \$758,997 from HHAP-5 Funding Category 4: Outreach, Hygiene, Prevention, and Supportive Services and \$3.6 million from HHAP-5 Funding Category 6: Administrative Costs and Systems Support is recommended to be allocated to the HHAP-5 Funding Category 3: Rapid Rehousing and Housing Navigation for a new budget total of \$16.3 million. This funding is recommended for Time-Limited Subsidies (TLS), which provide rental assistance for a more long-term housing opportunity for people experiencing homelessness. The recommended funding can serve up to 672 households, which is the same service level as Fiscal Year 2024-25. Each Time-Limited Subsidy slot has a cost estimate of \$24,309 per slot/household. Recommendations on how Time-Limited Subsidies will be programmed and spent will be addressed in a forthcoming Alliance report.

HHAP-5 Funding Category 4: Outreach, Hygiene, Prevention, and Supportive Services

The current budget for HHAP-5 Funding Category 4: Outreach, Hygiene, Prevention, and Supportive Services is \$24.1 million. As a result of the transfers to HHAP-5 funding categories 2 and 3, the new total budget for HHAP-5 Funding Category 4 totals \$14.1 million.

Hygiene Services

Funding in the amount of \$5.6 million is recommended to be allocated to the Board of Public Works to continue services for the Citywide Mobile Pit Stop and the Mobile Shower programs. The Pit Stop program provides mobile hygiene services for 12 hours per day and seven days a week. Secondly, the Mobile Shower Program operates two mobile shower trailers. Each trailer will cover at least three city-designated locations, from Tuesday to Saturday, four hours a day. This reflects a decrease of \$49,211 from Fiscal Year 2024-25; however, the 2025-26 budget is based on the expected need as determined by the Board of Public Works.

Funding is also provided for the Shower of Hope Mobile Shower program which provides mobile shower services five days a week in Council Districts 1 and 14. The continuation of a Mobile Laundry program is recommended to provide laundry services five days a week within Council District 1. Funding supports the purchase, maintenance,

and operations of the laundry trailer.

Lastly, funding is recommended for the Portable Hygiene Program, which provides portable toilets and hand washing stations services in the City in areas with high populations of encampments. Units are equipped with basic hygiene essentials such as soap, water, and towels.

Outreach Services

In 2023-24, the City Council and Mayor approved the expansion of the USC Street Medicine program. The program received \$1.9 million in General Fund in the Fiscal Year 2025-26 Adopted Budget for the base services, which reflects a \$20,022 reduction from Fiscal Year 2024-25 Adopted Budget. Aligning with the Adopted Budget, this report recommends HHAP-5 funding in the amount of \$1,463,269 and HHAP-3 funding in the amount of \$1,516,709, for a total of \$2,979,978 for the continued expanded services, which reflects a \$20,022 reduction from Fiscal Year 2024-25's budgeted HHAP funding. The USC Street Medicine Program provides primary care on the street, which includes treatment for acute and chronic disease, preventative medicine, treatment for psychiatric conditions, and substance use disorders. All care is provided on-site, including dispensing medications and drawing blood for laboratory testing. The teams will continue to provide services in Council Districts 1, 4, 5, 8, 9, 10, 13, and 14.

Funding is recommended for the Community Investment for Families Department's existing Clinica Romero contract in the amount of \$122,945 for services in Council District 14. This funding reflects 90 days of funding for the program to ramp down services. Medical services include: primary care, vaccinations, and women's health, at interim housing site(s) within the district.

Funding in the amount of \$1.6 million is recommended for this Office's outreach coordination. Funds will continue to support one Director of Outreach (Principal Project Coordinator) and five Regional Outreach Coordinators (Senior Project Coordinators). These positions will continue to work with Council offices to identify specific outreach needs and formulate plans to address them. This Office's outreach team works in close collaboration with all relevant City departments, LAHSA, and government partners to develop outreach policies and operating procedures, and oversee deployment of City departments and LAHSA for Recreational Vehicle (RV) dwelling and Comprehensive Cleaning and Rapid Engagement (CARE and CARE+) operations.

In Fiscal Year 2024-25, multi-disciplinary teams (MDTs) in Council Districts 5, 6, 8, and 9 were funded with HHAP-4, with a total budget of \$2.2 million. Due to the implementation of a coordination structure between the City and County for 34 MDTs funded by the County that operate exclusively within the City, HHAP funding for these MDTs is not recommended to continue next fiscal year. City-funded services in Council

Districts 5, 6, and 9 will not be continued; however, on May 12, 2025, Council and the Mayor approved \$600,000 in Additional Homeless Services - CD 8 funding to continue MDTs in Council District 8, through June 30, 2026 (C.F. 20-0841-S53).

Preventative and Diversion Services

Funding in the amount of \$788,886 is recommended to be continued for the Food Security Program, North Valley Caring Services, and Family Navigation Services in Council Districts 6 and 7 to provide food packets to individuals and families. Additionally, funding in the amount of \$300,00 is recommended for Rapid Resolution Specialists who are stationed at Family Source Centers to assist clients with identifying swift housing resolution and/or connecting clients with resources.

Other Supportive Services

There are various services that this report recommends continuing funding in the amount of \$1.4 million to LAHSA such as the Tarzana Treatment Center in Council District 3, the Downtown Women's Center Health and Wellness Program in Council District 14, The People Concern (TPC) Move-In Expenses in Council District 14, and Rapid Resolution Specialists in various council districts. The Tarzana Treatment Center provides supportive services for addiction, and substance use, while promoting recovery, increasing access to mental health care, and improving the determinants of well-being. Secondly, the Downtown Women's Center provides meals to women who are experiencing homelessness and women who are residing in Permanent Supportive Housing programs that receive services. Lastly, The People Concern's Move-in Expenses program provides moving assistance for the unhoused population and interim housing participants in Council District 14 who are transitioning into a permanent supportive housing unit.

HHAP-5 Funding Category 5: Set-Aside for Youth

The HHAP-5 program requires 10 percent of the \$164,335,500 award amount to be allocated to Transitional Age Youth programs. Programs under this category are to be determined and will be programmed in a future funding report for the Council and Mayor's consideration.

HHAP-5 Funding Category 6: Administrative Costs and Systems Support

HHAP-5 Funding Category 6: Administrative Costs and Systems Support are funds set aside to support administrative and staffing costs. The current budget for HHAP-5 Funding Category 6: Administrative Costs and Systems Support is \$11.5 million. As a result of the transfers to HHAP-5 funding categories 1 and 3, the new total budget for

HHAP-5 Funding Category 6 totals \$5.1 million.

Administrative Costs

Funding in the amount of \$1.4 million is recommended for the Office of the City Administrative Officer (CAO) for one Senior Administrative Analyst II and four Administrative Analysts to support the administration of all HHAP funded programs. HHAP regulations provide a seven percent administrative cap of the total grant allocation. The recommended amount represents 0.87 percent of the total HHAP-5 award.

Systems Support

City departments play a vital role in providing the project administration and management of various homelessness interventions and services funded through HHAP. This Report recommends funding for related City staff costs to provide the necessary oversight of the City's homelessness programs. Funding will support staff in the Board of Public Works, Bureau of Engineering, the Office of the City Attorney, Office of the CAO, General Services Department, and the Office of the Mayor.

Homeless Housing, Assistance, and Prevention Rounds 2, 3, and 4

1455 Alvarado Street in Council District 13 Fiscal Year 2025-26 Leasing Costs

On July 10, 2024, the City Council and Mayor approved the Homeless Housing, Assistance, and Prevention (HHAP) Round 1 and 4 Funding Report (C.F. 22-1157), which reserved \$588,468 in HHAP-4 funds for leasing costs of the Tiny Home Village (THV) at 1455 Alvarado Street in Council District 13, through November 30, 2027. This report recommends approving \$221,430 of the reserved HHAP-4 funds to support leasing costs through June 30, 2026.

10864 Rochester Avenue in Council District 5

The program located at 10864 Rochester Avenue in Council District 5 provides services to Transitional Aged Youth (TAY). The service provider on site, Safe Place for Youth (SPY), holds a lease agreement with the private property owner and serves up to 15 participants at a time. The recommendations in this report request LAHSA to enter into a sole source contract with SPY for the continuing services of this site. Furthermore, this report recommends a total of \$421,575 in HHAP-2 funds to support these services through June 30, 2026 at a \$77 bed rate. This Office released a report on May 23, 2025 (C.F. 23-1348-S1), introducing the proposed bed rates of \$116 and \$89 for TAY programs. If approved by Council and the Mayor, then additional funding will be identified to support the rate increase and included for approval in a future report.

1214 Lodi Place in Council District 13 Leasing Costs

The A Bridge Home program located at 1214 Lodi Place in CD 13 has been open and operational since November 2021. The program serves single adults and TAY, with the services funded through a joint effort between the City and the County of Los Angeles. The General Services Department, Real Estate Services division (GSD-RES) holds the lease with the private property owner. The recommendations in this report will transfer funds in the total of \$1,437,780 to GSD-RES so they may continue to pay the lease. HHAP-2 will fund \$17,529 of the lease for the month of June 2025. The remaining \$1,420,251 will be supported with HHAP-5 funds, which will cover the lease from July 2025 to June 2026.

Roadmap Outreach

The COVID-19 Homelessness Roadmap Agreement was executed between the City and County of Los Angeles in 2020 and aimed to shelter people experiencing homelessness (PEH) that are vulnerable to contracting the COVID-19 virus, sheltering within 500 feet of a freeway overpass or underpass, and aged 65 years or older. The Roadmap Outreach teams were developed to enhance the efforts of sheltering these target populations. This agreement is effective for five years and is slated to expire on June 30, 2025. This report recommends allocating \$870,968 in HHAP-3 funds to support the 90-day ramp-down process following the expiration of the Roadmap agreement and the demobilization of the outreach teams.

HHAP Obligation and Expenditure Deadlines

Each round of HHAP funding has obligation and expenditure deadlines set by State statute. These deadlines are provided below in Table 4. Obligation is defined as the amount of funding for which the grantee has placed orders, awarded contracts, received services, or entered into similar transactions that require payment. Expenditure is defined as the amount of funding fully paid.

The City has met all of the HHAP obligations and expenditure deadlines to date and expects to meet the HHAP-1 100 percent expenditure deadline of June 30, 2025. Table 4 also shows the expenditure deadlines for HHAP-6, for which applications are due August 29, 2025. The HHAP-6 application process is detailed in C.F. 20-1524-S8.
