The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.


The North Hollywood North East Neighborhood Council (NHNENC) fully supports this motion. ([CF 23-1277](#))

As the City's homelessness crisis has grown exponentially, our freeway underpasses and overpasses, bridges, tunnels, and other transportation infrastructure have become a focal point. While these locations may provide shade and shelter from the elements, they are incompatible with human habitation. Open flames, gas tanks and generators, excessive personal belongings, trash, and other flammable and hazardous materials in these encampments are not uncommon. When fires in and around our critical infrastructure occur, the lives, health and safety of those living in encampments at those locations, as well as the lives and safety of our City's first responders, are significantly jeopardized.

The NHNENC respectfully requests that the City should consider enacting legislation that would create safe barriers around our City's critical infrastructure, very high fire severity zones (as established pursuant to Los Angeles Municipal Code Section 57.4911.1.1 et seq.), and environmentally sensitive areas.
