**Comments for Public Posting:** Los Angeles county has been taken over by rogue aviation. LAPD helicopter pilots are the worse culprit of noise, fuel, and lead pollution over Los Angeles county. We are dealing with a form of systematic violence as noise, fuel, and lead pollution is linked to cancer, violent crime, dementia, heart disease and other health issues. We the People cannot and will not go on as normal in 2024. We are pushing an effort to withhold taxes and to form a new governance. Over 300,000 aviation noise complaints have gone ignored within a 3 year time period. Why are small air planes flying banners of nothingness over our homes? What are our senses being bombarded with that casual, noise, and fuel pollution to promote things like alcohol in our neighborhoods. There were two small planes with banners flying today over one residential neighborhood that doesn't have parks, that doesn't have rec centers but they have a plane flying a banner telling them to buy alcohol? We have a governance that does not respect sovereignty and that cannot and will not continue. We have a county wide issue with rogue aviation and that is how the issue must be addressed. From Long Beach, to West Adams, to Van Nuys, we have small planes and helicopters rumbling over our homes at all hours of the day and night. We have testimony of many residents moving out of Los Angeles bc the noise pollution from helicopters and small planes is so bad. The LA County board of supervisors took over a noise complaint app from grassroots advocates only to get rid of that app after never addressing any of the concerns from residents. We do NOT need a governance of NOTHINGNESS. We are NOT paying you to NOT address problems in real time. Los Angeles residents are being TAXED without adequate representation. SOLUTIONS: -Send these small airports out into remote areas - DO NOT GIVE LAPD ANOTHER HELICOPTER!!! LAPD helicopter pilots are terrorizing Los Angeles neighborhoods, we need smaller intentional districts with direct community investments and support systems. Los Angeles teachers were complaining to LA Controller about the disruption from LAPD helicopter pilots at night when their students and staff are sleeping but also during the day, this is a threat to collective community health. -Aerial Media Group uses small planes to fly banners across Los Angeles county, we do NOT want that in our neighborhood. We have

traditional billboards for companies to use. While we are AT HOME and out we should not have small planes dumping lead, noise, and fuel pollution to promote nonsense. Literally poisoning our air and telling us to buy alcohol which is poison -Corporate media needs to be banned from flying helicopters all day and night over our neighborhoods. FAUX news, ABC, NBC, etc. helicopter pilots are literally hovering over our communities at all hours of the day and night. 
