SUBJECT: Municipal Codes Similar to LAMC 41.18

SUMMARY

Motion (Park, Krekorian et al.—Padilla, C.F. 24-0140-S1) requests the City Attorney to provide an analysis of the United States Supreme Court decision, dated June 28, 2024, in City of Grants Pass, Oregon vs. Johnson. The City Attorney's analysis is to include the ruling's impact on the City's existing rules relative to sleeping, lying and storage of property in the public right-of-way, and other public settings, including but not limited to Los Angeles Municipal Code (LAMC) Sections 41.18, 56.11, and 63.44, as well as its impact on vehicle dwelling. The Motion also requests the City Attorney to provide a confidential analysis regarding the ruling's impact on any existing litigation, including the LA Alliance Settlement, against the City. Finally, the Motion instructs our Office to report to Council on current laws in the other 87 cities within Los Angeles County that restrict sleeping in public rights-of-way that will impact the City. Amending Motion (Soto-Martinez-Rodriguez) further instructs our Office, alongside this analysis, to report on the estimated annual costs for enforcement from law enforcement agencies, City personnel, and other associated expenses, including those related to courts, jails, and citations processing.

For the purposes of this analysis, our Office compares the municipal code of other cities in the County to LAMC 41.18, as LAMC 41.18 includes the prohibition against sleeping in the public right-of-way. In effect, we compare the code of other cities to all components of LAMC 41.18, not simply sleeping in the public right-of-way. In this report, we summarize LAMC 41.18; discuss sensitive use zones, and reference previous CLA reports on the subject matter for additional context and in order to institute a similar framework of analysis. In direct response to Motion, Attachment I provides a summary of our findings relative to municipal codes across all 87 cities in Los Angeles County that appear similar in substance to LAMC 41.18, while Attachment II provides extracts of the actual text of those municipal codes. Finally, this report addresses amending Motion (Soto-Martinez-Rodriguez) and references previous CLA reporting on the cost of enforcement of LAMC 41.18. It also highlights challenges to collection of privileged data held by other jurisdictions.

RECOMMENDATION

Note and file the report.

BACKGROUND

A 2019 Motion (Rodriguez-Huizar, C.F. 19-0513) instructed our Office to conduct a review of laws similar to LAMC 41.18 in other California jurisdictions. The report, dated June 22, 2020, reviewed the municipal codes of nine other cities: Burbank, Carson, Culver City, Glendale, Long Beach, Pasadena, San Fernando, Santa Monica, and Torrance. It found that six of the nine cities had laws to prohibit sleeping and storage of property in public, and that several such ordinances were pending implementation at the time. The report also considered Vehicle Dwelling, as well as public safety and enforcement responses, which are outside the scope of this report. The June 2020 report provides a framework for this analysis, and structures the format of the information found in Attachment I and Attachment II to this report.

Motion (Yaroslavsky–Price Jr., C.F. 21-0329-S4) subsequently instructed our Office to report on the implementation of 41.18. The report, dated May 31, 2024, noted that, since the issuance of the former report, several jurisdictions including the City of Los Angeles, have adopted revisions or made entirely new laws on the subject. The report also provided a summary of the four components of 41.18, which we reproduce for the purposes of this analysis, below.

Los Angeles Municipal Code: 41.18

The full language of LAMC 41.18 (Chapter IV Public Welfare) is provided in Attachment III to this report. In sum, LAMC 41.18 comprises four general prohibitions against occupying public space in an obstructive manner. Those prohibitions are as follows:

- a) Sitting, lying, sleeping, storing, or maintaining personal property that obstructs a street, sidewalk, or other rights-of-way within a specific distance, such as driveways (10 feet), building entrances (5 feet), or fire hydrants (2 feet);
- b) Obstructing any portion of any street or other public rights-of-way open to use by bicycles or other vehicles;
- c) Storing, sleeping, sitting, maintaining, or placing personal property up to a maximum of 500 feet of a property designed as a "Sensitive Use" (see below), or other area identified by the Council through resolution; and
- e) Storing, sleeping, sitting, maintaining or placing personal property within 500 feet of a School or Day Care Center.

It should be noted that Ordinance No. 187127, effective September 3, 2021, revised LAMC 41.18 to remove and transfer prohibitions formerly included under section (d) to section (a). As revised, the current section (d) is not material to this analysis, because it is administrative in nature and relates only to conditions upon which the prohibitions may be enforced.

Sensitive Use Zones

LAMC 41.18 (c) designates areas of the City within 500 feet of a public park, library, freeway overpass and underpass, or homeless shelter, as a sensitive use zone. It further reserves the right for Council to designate, by Resolution, other areas of the City as sensitive use zones. The circumstances that allow for the City to designate other areas as sensitive use are threats to public health and safety. LAMC 41.18 (e) further designates areas within 500 feet of schools and day care centers as sensitive use zones, to which the same set of prohibitions found in LAMC 41.18 (c) apply.

CLA review of the municipal codes of the 87 other cities in Los Angeles County finds that no other municipalities use the term "Sensitive Use," though they may prohibit obstructing the public rights-of-way surrounding designated locations in a similar manner. Further, the locations cited by LAMC 41.18 for sensitive use, e.g., Parks, Overpasses/Underpasses, Homeless Shelters, Schools and/or Daycare Centers, and Libraries, etc., are not shared in full by any other municipality. For example, several municipal codes prohibit sleeping in parks in a similar manner to LAMC 41.18; however, very few make mention of the other types of locations under LAMC 41.18 (c) and (e). At the same time, several municipal codes designate community-specific landmarks as similar to sensitive use zones. Additionally, while some codes define specific distances from the designated places or infrastructure around which it is prohibited to occupy space, 500 feet is not a standard measurement. Instead, the distances stipulated for sensitive use can vary widely, ranging from within 25 feet to within an area bounded by certain sidewalks around a landmark.

To compare the City to the other 87 cities in the County, we used a flexible approach to our review of laws similar to LAMC 41.18 (c) and (e) that includes locations in which or around which it is prohibited to occupy space. However, since all municipal codes that we reviewed specify the hours and times during which it is impermissible to occupy space in public parks, all public parks would be considered sensitive use zones under this flexible approach. As a result, our review of laws similar to 41.18 (c) and (e) only includes municipal code relative to public parks if additional landmarks are included within the park rules. This distinction allows us to identify municipal codes that include locations that other cities designate similarly to sensitive use zones, not simply parks generally.

DISCUSSION

This report seeks to update the initial analysis on nine jurisdictions, found in the 2020 Report, to now consider the municipal code of all 87 cities in the County. The findings of this report are included in two attachments, which appear in the form of tables. Attachment I summarizes the findings by indicating whether similar and/or relevant code exists, and provides some additional context. Attachment II provides the exact language of the municipal code, which we consider similar in substance to any component of LAMC 41.18.

It should be noted that other municipal codes name specific actions, such as camping or loitering. Neither camping nor loitering appears in the prohibited activities described in LAMC 41.18. However, lying and sleeping are presumably prerequisites of camping, and standing is similarly a prerequisite for loitering. Therefore, we consider such language to be materially

relevant to 41.18, and include those instances in our findings. Similarly, several codes cite encroachment as a prohibited activity, and we include those instances as well, since this language mirrors 41.18 (a) prohibitions, relative to maintaining distance from particular infrastructure.

For this reason, our findings include actions that are similar to the prohibited activities, but which may not be named directly in LAMC 41.18. Further, we interpret 41.18 (b) broadly to include any prohibitions against obstructing a street or sidewalk, since both types of infrastructure are "public rights-of-way open to use by bicycles or other vehicles," per LAMC 41.18 (b) language.

Attachment I

Provided in Attachment I is a summary of our findings. This table includes the four components of 41.18, and notes whether we found corollary code to any of the four 41.18 components in a given city. We note "No Law" when applicable law could not be found. We also include the number of homeless individuals observed in each city in the 2024 Point-in-Time Count, which means the number of sheltered and unsheltered homeless per 10,000 residents. We present this information to place the municipal code within the context of the severity of the homelessness crisis in each municipality. Further, Motion (Park, Krekorian et al.—Padilla) instructs that we report on laws in the other 87 cities that are similar to 41.18, that will impact the City. The extent to which a municipality is experiencing the homelessness crisis may make the respective code more impactful to the city.

Attachment II

Provided in Attachment II are the complete findings associated with our Office's review of municipal code. Relative to each city's municipal code, we reproduce the specific section, as well as the language of the provision that is substantially similar to LAMC 41.18 prohibitions. That language may be abbreviated for clarity. We also provide a population estimate, rounded to the nearest one-thousand people, of the municipality. This is included to provide additional context for the potential impact a given provision might have on the city.

Several municipal codes note exceptions to their 41.18-style laws; for example, pursuant to viewing parades, sitting on public benches, or due to compliance with the federal Americans with Disabilities Act of 1990. We do not include these criteria, or any similar such exceptions, in our analysis. Additionally, we did not include nuisance or encroachment laws in our analysis in the case that these laws apply to real property, meaning private parcels of land. Finally, it should be noted that Motion (Park, Krekorian et al.—Padilla) instructs our Office to undertake an analysis of prohibitions against sleeping in the public rights-of-way, so we do not include evaluation related to provision (f) of LAMC 41.18 that addresses enforcement.

Finally, it should be noted that findings included in Attachment II cite municipal code that is subject to revision at the discretion of the respective governing body. As well, municipal codes may include sections substantially similar to LAMC 41.18, but which are not situated within the Public Welfare Code, as not all jurisdictions include a specific chapter relative to Public Welfare. As such, all cities structure their municipal code differently, and our ability to capture and extract all sections of code relevant to the substance of LAMC 41.18 may vary accordingly.

Costs of Enforcement

In response to amending Motion (Soto-Martinez-Rodriguez), the CLA provides previous reporting on costs associated with implementation of LAMC 41.18. We further discuss challenges to the reporting of data from jurisdictions, which are external to the City, and with whom the City has not executed data sharing agreements.

CLA Report, dated May 31, 2024 (C.F. 21-0329-S4), states that the City Administrative Officer (CAO) estimates the cost to the City of implementing LAMC 41.18 to be \$2.83 million from September 2021 through December 31, 2023. This amounts to an annual expenditure of \$1.31 million, which is divided into two component costs: the cost of installing signage and posting notifications, and the cost of staff situated in the CAO's Office who coordinate with other City entities, relative to the ordinance's implementation. These costs are variable in relation to the number of new 41.18 sites designated by Council. However, the CLA report also states that costs of law enforcement are not available since City departments, including Police, were unable to disaggregate their labor costs associated with 41.18-specific expenditures from their departmental expenditures. As a result, we are not able to produce data that would inform cost estimates with respect to the enforcement of any specific City ordinance, including 41.18.

Amending Motion (Soto-Martinez-Rodriguez) also instructs our Office to consider costs of enforcement of 41.18-style ordinances in the other 87 cities. However, jurisdictions outside of the City are under no obligation to provide internal reporting on disaggregated expenditures related to enforcement of specific ordinances. Further, even if the City had executed data agreements that could allow our Office to query other law enforcement agencies in the other 87 cities, these jurisdictions would be similarly unable to disaggregate the costs of enforcing specific ordinances, including ordinances that share substance with 41.18, as the data to inform such an analysis does not exist.

FISCAL IMPACT STATEMENT

There is no fiscal impact associated with this report.

- (a) No person shall obstruct a street, sidewalk, or other public right-of-way:
 - (1) by sitting, lying, or sleeping, or by storing, using, maintaining, or placing personal property, in a manner that impedes passage, as provided by the Americans with Disabilities Act of 1990, Pub. L, No. 101-336, 104 Stat. 328 (1990), as amended from time to time;
 - (2) by sitting, lying, or sleeping, or by storing, using, maintaining, or placing personal property, within ten feet of any operational or utilizable driveway or loading dock;
 - (3) by sitting, lying, or sleeping, or by storing, using, maintaining, or placing personal property, within five feet of any operational or utilizable building entrance or exit;
 - (4) by sitting, lying, or sleeping, or by storing, using, maintaining, or placing personal property, within two feet of any fire hydrant, fire plug, or other fire department connection;
 - (5) by sitting, lying, or sleeping, or by storing, using, maintaining, or placing personal property, within the public right-of-way in a manner that obstructs or unreasonably interferes with the use of the right-of-way for any activity for which the City has issued a permit.
- (b) No person shall obstruct any portion of any street or other public right-of-way open to use by motor vehicles, or any portion of a bike lane, bike path, or other public right-of-way open to use by bicycles, by sitting, lying, or sleeping, or by storing, using, maintaining, or placing personal property, anywhere within the street, bike lane, bike path, or other public right-of-way, as specified.

 - (3) sit, lie, sleep, or store, use, maintain, or place personal property, in or upon any street, sidewalk, or other public right-of-way, within the distance stated on the posted signage (up to a maximum of 1,000 feet) of a designated facility, opened after January 1, 2018, that provides shelter, safe sleeping, or safe parking to homeless persons, or that serves as a homeless services navigation center;
 - (4) sit, lie, sleep, or store, use, maintain, or place personal property, in or upon any street, sidewalk, or other public right-of-way that has been posted with signage prohibiting sitting, lying, sleeping, or storing, using, maintaining, or placing personal property. For each such location, a prohibition pursuant to this subdivision shall be effective for a period of time specified in the resolution, but not to exceed one year.
- (d) No person shall be found to be in violation of any prohibition set forth in Subsection (c), unless and until: (i) the City Council has taken action, by resolution, to designate a specified area or areas for enforcement against sitting, lying, sleeping, or storing, using, maintaining, or placing personal property, or otherwise obstructing the public right-of-way; (ii) the City has posted signage at the designated area or areas set forth in the resolution, with such signage including reference to any required findings adopted in the resolution, and giving notice of the date after which no sitting, lying, sleeping, or storing, using, maintaining, or placing personal property, or otherwise obstructing the public right-of-way will be allowed; and (iii) at least 14 calendar days have passed from the date on which the signage is posted at the designated area or areas.
