Greetings:

The Los Angeles Police Department (LAPD) was recently notified regarding the pending application for a commercial cannabis license at **2043 Imperial Street**. Please be advised that the LAPD, Specific Area, is adamantly opposed to the granting of this license at this location.

I ran crime & calls for service (CFS) within 500 ft of 2043 Imperial from 01/01/21 to 04/10/24

Crime:

- ADWs – 6
 - Burglary/Theft from Motor Vehicle – 4
 - Burglary – 10
 - GTA – 13
 - Battery – 4
 - Theft – 5
 - Vandalism – 2
 - Shots Fired Incidents – 3 (1 ADW on Police Officer & 2 Shots Fired City Limits)
- 41 Total CFS within 500 ft of location, 3 specifically at 2043 Imperial Street. All CFS at the location were for alarm calls, and location already appears to be in operation without the proper licensing requirements.

Whether the business is licensed or not, these types of businesses attract crime to the area. There has also been an increasing number of burglaries at these cannabis businesses throughout Newton Area, some resulting in shootings and police pursuits that endanger the general public. With the department's decreased resources in the recent years, the department's ability to provide adequate public service is greatly impacted when dealing with issues resulting from cannabis businesses.

3.3.1

An additional basis for this opposition is the over-saturation of existing cannabis licensed locations within the community plan area of Central City North. A review indicates that **3** cannabis business premises are allowed within this tract. Currently, there are **6** existing licensed cannabis business locations, representing an over-saturation rate of **100 percent**. The closest licensed retail cannabis business is **1 mile** from the proposed location. This places an undue hardship on the community and should be of significant consideration in the justification to deny the license.

Should this license be issued despite our objections, it is reasonable to assume that the licensee will be encouraged to take a proactive role in protecting the welfare of its patronage and the public.

The LAPD invested considerable time and resources to bring about the closure of illegal cannabis businesses throughout the City. The removal of these locations has significantly enhanced the quality of life in the surrounding communities. We would not like to see our efforts be invalidated with the approval of another cannabis location in an area that already is oversaturated with this type of business.
